The much loved Let's Move @Cliddesden is held every Monday during school term times, it free of charge, with tea coffee & biscuits around a natter & chatter table afterwards.

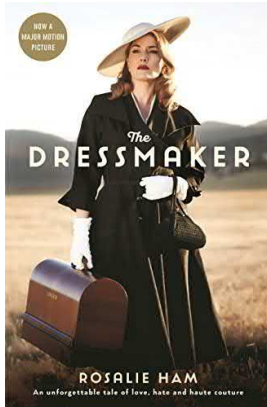

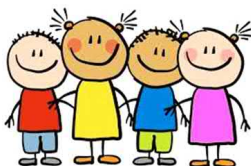

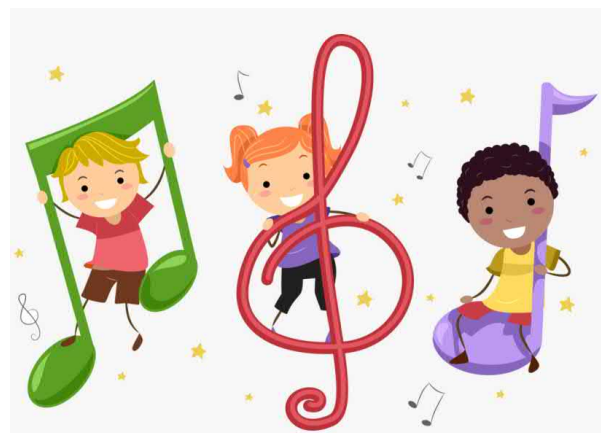

NOTES FROM THE JULY PARISH COUNCIL MEETING

The meeting was attended by three Parish Councillors, the Clerk and five members of the Public.

The Public Session considered a question on business advertising boards. Does the Parish Council have a view on advertising signage?

This is subject to legislation and policy, and a matter for BDBC as the Local Planning Authority. If signs are blocking pavements, then an issue of obstructing the Highway.

The Parish Council agreed to draft a guidance document on advertising signage for the Parish.

Reports to the meeting From County Councillor, a written report, extracts on facing page; from Ward Councillors, the new BDBC Cabinet is taking stock of current policies and projects; nothing to report from PCSO Andy Jones for Cliddesden which hopefully is good news.

Review of the Parish Assembly Generally agreed to have been successful and well received. People engaged, the buffet appreciated, and a good sociable atmosphere, Thanks to all who attended.

Festival licensing application for Cosmic Roots Music & Arts Festival, Kingsmore Copse, Northgate Lane, Ellisfield. Considered by BDBC Licensing Sub-committee at public hearing on 04 July, available to view on YouTube.

A public demonstration at the Civic Offices before the hearing conveyed the level of interest and concern. The hearing was well attended with everyone able to make their points; all Cosmic Roots directors present and contributing; the Chairman and Simon Barker spoke on behalf of the Parish Council. Parish Councillor Gordon Dunce spoke for Ellisfield.

The Licensing Sub-committee can focus only on licensing matters – and issues relating to Crime and disorder, Public safety, Prevention of public nuisance, Child protection. An initial licence application is hard to refuse as most issues in theory can be overcome.

A new route is proposed from the M3 J7 via A30, through Hatch Warren to Garlic Lane, through Farleigh Wallop to the field.

Noise levels will be measured within 1km of the site at midnight before the event. This then considered to be the 'base level' noise and noise levels during the event will be monitored against this.

Environmental impact on an ancient woodland site is outside the scope of licensing.

The Cosmic Roots licence was granted but the event has been rescheduled for September 2024

OUTDOOR ADVERTISEMENTS AND SIGNS: A GUIDE FOR ADVERTISERS

*From: Ministry of Housing, Communities & Local Government
Published 18 June 2007*

The advertisement control system in England consists of rules made by the Secretary of State, which is part of the planning control system. The present legislation is the Town and Country Planning (Control of Advertisements) Regulations 2007.

There is also an official Circular and Planning Policy Guidance Notes, produced by Communities and Local Government – *Circular No 03/2007 and DOE Planning Policy Guidance (PPG) Note No 19.*

Throughout England, local planning authorities (LPA) are responsible for the day-to-day operation of the advertisement control system, and for deciding whether a particular advertisement should be permitted or not.

All outdoor advertisements must comply with five Standard Conditions. They must – be kept clean and tidy; be kept in a safe condition; have the permission of the owner of the site on which they are displayed (this includes the Highway Authority if the sign is to be placed on highway land; not obscure, or hinder the interpretation of official road [or other transport] signs; be removed carefully where so required by the LPA.

An outdoor advertisement is permitted without the LPA's specific consent if it complies with specific provisions. For example Class 2(B) permits notices or signs to be displayed on any premises for the purpose of advertising... a profession, business or trade at those premises... and must not exceed 0.3m² in area. Class 2(C) permits notices or signs which relate to any religious, educational, cultural, recreational, medical or similar institution... provided that the advertisement is displayed at the premises and does not exceed 1.2m² in area.

Every LPA is obliged to consider whether any part of their area should be an area of special control for advertisements because of the need to protect amenity... The effect is to limit some categories of advertisement that benefit from deemed consent. Areas of special control are likely also to be Conservation Areas, but one designation does not follow the other.

COUNTY ISSUES: EXTRACTS FROM JULY REPORT

From County Councillor Juliet Henderson

Household Waste Recycling Centres – Improving Recycling and Reuse From July, residents are being asked to separate their waste ahead of a visit to the Recycling Centre (HWRC). The HWRC teams will be on hand to answer any questions and offer advice. In addition, there are re-sale sections at all sites where reusable items can be left.

Residents need to book an appointment via the County Council's website before visiting. Also check the website to find out what is accepted at your local Recycling Centre. Most Hampshire HWRCs will be able to recycle the following materials:

Garden and green waste; metals; wood; cardboard; electrical equipment and appliances; batteries, printer cartridges and light bulbs; furniture; clothing and textiles; paints, chemicals, engine oil and gas bottles.

Lead role in Local Nature Recovery Hampshire County Council has been appointed by Government to prepare a Local Nature Recovery Strategy for Hampshire in collaboration with key partners and with £388,000 provided to coordinate development. The Strategy will bring together organisations and residents to restore precious habitats, protect wildlife and combat climate change. Hampshire County Council is one of 48 local authorities across England designated as Leads for the delivery of Local Nature Recovery Strategies and will work with Southampton and Portsmouth unitary authorities, the two National Parks and all 11 District and Borough councils across Hampshire.

Road works are sometimes advertised but don't happen If you wonder why... The teams carrying out road repairs are those who also respond to emergencies, so if they are called away the work has to be re-scheduled.

COUNTY ON POTHOLES

Our County Councillor is conscientious in providing updates as to the whys and wherefores of Hampshire's strategic approach to repairing potholes. So to share here some extracts from Cllr Henderson's reports...

Why so many? Last winter's cycles of heavy rain and frosts were more perfect than usual for potholes. Freeze - thaw action of water in cracks rapidly weakens and break open road surfaces. Then there is the hydraulic effect of vehicle tyres constantly going over standing water in cracks and other small surface defects – which is why potholes are continuing to develop and why some of the temporary fixes are beginning to break down.

Why the temporary fixes? Due to the sheer number of potholes, HCC's Highways team took the decision to keep roads serviceable and safe with emergency infill repairs because four to seven temporary infills take the time of one more permanent fix.

But... replacing the temporary fixes and returning the highway network to its pre winter condition is likely to take most of this calendar year. This has been helped by a Government allocation of £6M for pothole repairs.

What Hampshire does next? The County Council is planning to commit a further £22.5M to support the road repair programme in Hampshire over the next three years (£7.5M per year). As part of these proposals, contractors have been asked to adjust their working method so that when a single repair is made, smaller ones nearby can be filled at the same time. The repair teams at the moment are asked to fix only the defects that pose the biggest risk. This new repairs programme and funding was agreed by Cabinet on 18 July.

Sport has always been a great love and back in my younger days I was a very active cricketer, rugby and footballer player whilst also enjoying many racket sports.



I am Dave Rudge and I have been a Parish Councillor for Cliddesden for just short of a year now. I am currently managing the two Speed Indicator Devices (SIDs) in the village. This involves keeping the batteries charged, downloading the traffic data, summary reporting, and moving one device around nine roadside locations. I am also co-keeper, and user, of the CPC battery hedge trimmer.

I have lived in Hackwood Lane for the past 9 years, and previously lived in Brighton Hill for 19 years.

My hobbies include DIY, gardening, walking and cycling. I am also a volunteer collector for TWAM which is a charity that collects unwanted tools, refurbishes them, sorts them into trade tool kits and sends them to African countries for livelihood creation.

My professional history is as an electronics design and manufacturing engineer for a number of electronics companies around the UK for 42 years. After sitting at a desk and computer for this length of time, I was keen to get outside and perform largely physical tasks during my retirement. The fact that these tasks benefit Cliddesden in a small way is my motivation for being a councillor.

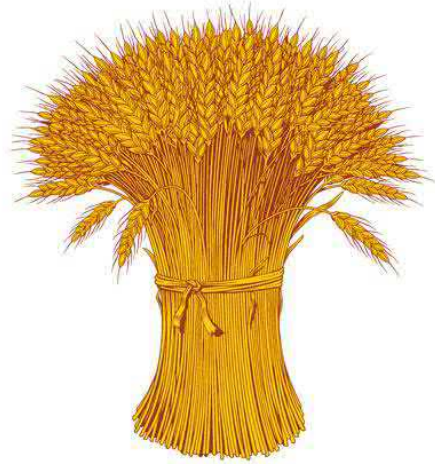
It is envisaged that it will start on Thursday 14th September at 7.30pm and continue for 9 weeks.
