

External auditor report 2017/18

On 28 September 2018 we issued a report detailing the results of our limited assurance review of Sections 1 and 2 of this authority's Annual Governance & Accountability Return for the year ended 31 March 2018. We explained that we were unable to certify completion of the review at that time. We are now in a position to certify completion of the review.

The external auditor report given in Section 3 of the Annual Governance & Accountability Return requires amendments as follows:

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR.:

- Unpaid direct debits as at the year end have been incorrectly included as items of expenditure and as reconciling items in the bank reconciliation. The figure in Section 2, Boxes 8 should read £106,437.
- Section 2, Box 10 is inconsistent with the balance published by the Public Works Loan Board. The figure in Box 10 should read £61,928.

Other matters not affecting our opinion which we draw to the attention of the authority:

The smaller authority has not provided:

- one of the year end bank statements to support the bank reconciliation to Section 2, Box 8. These were requested as part of our intermediate review procedures. We note that the HSBC BANK statement provided shows the balance as at 12/03/18, but we have been unable to verify the year end balance.
