Minutes of the meeting of Lathom South Parish Council held at the Cricket Club, Blaguegate Lane, Lathom, WN8 8TY at 7:30 pm on Wednesday 14th June 2023

MINUTES

1 To record apologies for absence

Apologies were received from Cllr Blackledge, Cllr Chanter and Cllr Taylor.

2 To receive declarations of interest

There were no declarations of interest.

To sign as a correct record the minutes of the meeting held on the 10th May 2023

The minutes of the AGM meeting held on 10th May 2023 were accepted as a true record and duly signed by the Chairman.

4 To hear acceptance of office for Cllr Andrew Beeston and confirm Registration of Interest Form

Declaration of acceptance of office was read out by Cllr Andrew Beeston, witnessed and signed. The registration of interest form would be completed later.

a. Request for deer crossing warning signs for Spa Lane

The meeting concluded that more information would be required in order to substantiate a request to LCC for deer crossing warning signs on Spa Lane. Residents are to be asked to log any sightings of deer on Spa Lane, including which section of road the deer are using as a crossing point.

6 Tree Wardens Report

There was nothing for the tree warden to report.

7 To discuss future plans for Jacobs Wood and Swells Wood

The meeting discussed how to move forward with the idea of making a circular path around Swells Wood. It was agreed to enquire with Andrew Greenough if he would carry out a survey of Swells Wood with regard to making a basic circular pathway for walkers.

The meeting discussed making access into Swells Wood, from Plough Lane, suitable for a maintenance vehicle via a gated entry with a separate pedestrian gate. The options of fencing and/or hedging were considered for securing the boundary on either side of any gates. It was agreed to first consult with Andrew Greenough to establish how much vehicle access is needed for future maintenance and how best to make an access route without causing potential traffic problems on Plough Lane through undesirable parking by towing and other vehicles.

9 To receive internal audit, complete Annual Governance & Accountability Return 2022/23

The Clerk presented the Annual Governance & Accountability Return 2022/23 as it had been presented to the internal auditor. The accounting statements were signed off as correct and will be submitted to the external auditor in due course.

10 To consider membership to NALC (National Association of Local Councils)

Currently a full year membership to NALC for Lathom South Parish Council would be £182.06 which includes LALC (Lancashire Association of Local Councils) membership. Membership fees to NALC are based on the number of electors in the Parish. The LALC element of the fee is equally divided amongst the number of Parishes taking membership.

As the membership year runs from 1st April there would be a discount for the first year. The Clerk advised that the membership cancellation

policy states notice of cancellation is required by 30th September for cancellation from 1st April the following year.

It was noted that NALC/LALC membership had not been included in the 2023/24 budget. However, budget savings had been made in other areas which would offset the cost.

It was resolved to join NALC/LALC with immediate effect.

11 To discuss any current planning issues:

There were no current planning issues for discussion

12 To discuss and agree relocation of 'Slow Down, Save Lives' banners (SDSL)

The SDSL banners on Vale Lane had been in place for the limited 12 weeks and therefore removed. The condition of one banner had deteriorated beyond repair. It was agreed to request a replacement banner from the LCC Speed Management Team and then relocate both banners back on Dicks Lane for 12 weeks.

13 Update on traffic calming proposal for Firswood Road

A drafted proposal for traffic calming for Firswood Road, as previously discussed, was approved by Councillors. It was resolved to forward a copy of the proposal to Dave Allen at LCC Highways with a covering letter. Copies are to be sent to Cllr Rob Bailey and the new Borough Councillors following the local election on 22nd June.

Continuing issues relating to Firswood Road were still being addressed.

The Clerk had been advised that an application for funding for a community defibrillator to the England Cricket Board is underway.
