


This means any beneficial interest in land within the area of Tichborne Parish Council of yourself, or your partner.




### 5 Licences

This means any licence (alone or jointly with others) to occupy land in the administrative area of the Tichborne Parish Council held by yourself, or your partner, for a month or longer.



NOTE: A body in which you or your partner have a beneficial interest means a firm in which you or your partner is a partner, or a body corporate of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest.



I understand that (without reasonable excuse);

- (a) failure to register any disclosable pecuniary interest required to be registered under Section 30(1), 31(2), 31(3), or 31(7) of the Localism Act; or
- (b) to participate in any discussion or vote in any matter considered at a meeting where I have a disclosable pecuniary interest in the matter in contravention of Section 31(4) of the Localism Act 2011; or
- (c) to knowingly or recklessly provide information under Section 30(1), 31(2), 31(3), or 31(7) of the Localism Act 2011which is considered to be false or misleading;

is a criminal offence under Section 34 of the Localism Act, punishable by a fine not exceeding level 5 on the standard scale (currently £5,000), and disqualification as a Member or Co-opted Member of Tichborne Parish Council or any other relevant authority for a period not exceeding five years.
