Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.
The AGAR was not accurately completed before submission for review: • The balance brought forward from the previous year of £33,051 (Section 2, Box 1) does not agree to the prior year balance carried forward of £32,551 (Section 2, Box 7), due to an unpresented cheque being incorrectly included in the bank reconciliation in the prior year. Section 2, Box 7 of the prior year should read £33,051. For the same reason, Section 2, Box 6 of the prior year should read £8,307.
