#### PLANNING APPLICATIONS WITHIN MARDEN PARISH: 247/16

16/502066/FULL - 3 Chantry Place, Church Green (a)

Two storey side extension

After discussion and viewing the plans Cllrs had no objection to this application. However Cllrs wished to see a condition that the property is kept as one and not converted to a separate dwelling.

- 16/501596/FULL The Mount, Summerhill Road (b)
  - Installation of 4 external lights to sand school

Cllrs had no objection but wished to see a condition that lights are to be switched off by 9pm.

- (c) 16/501560/FULL - Oak Cottage, Maidstone Road
  - Construction of driveway to new timber double garage

After viewing the plans Cllrs were of the opinion that the area outlined for the proposal is not within the existing garden curtilage. They therefore recommend refusal. However if this is not the case they welcome any additional information and will review the application with new details.

Several households in Marden had also received documentation. No planning application has yet been submitted to MBC. KALC Area Committee had arranged for Parish Councils to meet with Rob Jarman of MBC on 11<sup>th</sup> April. Cllrs felt that they did not wish to attend as the Parish would liaise direct with MBC Planning if it had any issues.
