The Clerk reported on the Precept requirements for 2013/2014 at which it was agreed at the last parish Council meeting that the precept amount should remain at £3,939.

It should be noted that from 2013-14 the Council Tax Rebate System is to be replaced by a Local Council Tax Support Scheme which will now be part of the Council Tax System rather than a welfare benefit with the Government only funding 90% of the cost as opposed to 100% of the cost.. To help fund the shortfall of 10% Shropshire Council has made changes to various Council tax Concessions such as the abolishment of the second home discount.

This has an impact to the Parish Council because although the precept amount remains at £3,939 it will still result in an increase in Parish Council Tax Rate of approximately 3%.

Due to the changes to the rebate system the precept will be met by £3,597 being collected through the Council Tax System and a Council Tax Support Grant of 342.

7. Planning Items:

The Clerk referred to the Draft Management Policies consultation being undertaken by Shropshire Council these will replace the existing saved policies from the former district councils merged into Shropshire

The consultation period is from the 31st January to the 28th March 2013 the Clerk will forward appropriate details to each Parish Councillor for consideration and to notify the Clerk of any comments prior to the consultation end date.

The Localism Act makes fundamental changes to the existing Standards Regime with new arrangements brought into force from the 1st July when the old statutory requirements for the code of conduct will cease to have effect.

Regulations have now been drafted which define what constitutes a "disclosable pecuniary interest". Town and Parish Councils are required to publicise the adoption revision or replacement of a code of conduct in order to bring it to the attention of persons who live within the area and this can be done in conjunction in a joint advert with Shropshire Council.

Shropshire Council has produced a Code of Conduct based on the requirements of legislation of the Localism Act and it is recommended by the Shropshire Association of Local Council's that this model is adopted by all Shropshire Councils.

Members of Town and Parish Councils are required to register their disclosable pecuniary interests in a register held by the Monitoring Officer members need to declare not only interests that affect yourself but also their partners. The register will be available on Shropshire Council website and also each individual council websites. Members risk committing a criminal offence if they do not disclose their pecuniary interest before a meeting

The Parish Council agreed to adopt the Code of Conduct produced by Shropshire Council from the 1st July 2012. Members were informed that they should return the form which was included with to the Clerk or Monitoring officer without delay.
