- a) Budget for 2021 / 2022- Unanimously agreed by all that precept for 2021/22 will remain at £10,900.
- b) All agreed to provide 2 x £50 voucher for field / maintenance volunteers.

10. Playing Field

- a) Appleby Girls CC
- i) Appleby are keen to start playing at Newton Regis next season.
- b) Ride on Mower
- i) Appleby are selling their mower, which is in better condition than Newtons. If the price is good value, all agreed to purchase from Appleby. Mr Snelson pointed out that it may be possible to bid for funding for a new mower from the Mercia Fund. All agreed to bid for one.

11. Playground

i) Playsafety RoSPA inspection report found that the nest swing was set at the wrong height. The supplier said equipment set to correct height. Playsafety reviewed and agreed nest swing was set at the correct height.
 ii) The handle on the springle has been bent. DW has bent back into correct position.

iii) **Spring Horse** - DW has the clamps to replace. Access is difficult and Adie will help.

12. Mercia Park

- a) Community Fund Mr Snelson reported that there was £350k in the fund. £100k has already been allocated. Proximity to Mercia Park should give priority to applications for funding from NMH. Closing date for applications is 8/2/21. Suggestions for bids: mower for Newton Regis, replacement safety matting for Newton Regis playground. NMH Village Hall and NMH Church are entering their own bids.
- b) **Community Liaison -** last meeting reported that the roundabout on the Ashby Road is next to be completed. JLR are still fully committed to Mercia Park.

13. Salt Street

Existing rights of way and footpaths must be added to the Definitive Map by 2026. A restricted by-way application has been submitted to Leicestershire County Council by the British Horse Society for Salt Street. Change to a restricted access by-way would be a down-grade and prevent access to motorised vehicles. It has no classification at present, therefore any vehicle is allowed to use it. There must be a condition to exempt farm vehicles that need access.

Salt St. classification is not up for consideration at the present time, as there is a waiting list. Maintenance was passed from WCC to LCC and was last maintained by LCC in the 1990s.

The Parish Council can write to LCC in support of the classification and the Clerk to inform the residents of NMH Clerk when it come up at LCC. NWBC can also support the classification.

14. Telephone Box

A qualified electrician needs to look at moving the defibrillator from the wall at Manor Farm to the telephone box. DC DC to ask Mr Hopkins to quote for repairs to wooden roof and re-painting exterior.

15. Tree on St. Mary's Grove

The trunk has split on the bush which leans onto the footpath. Bush needs removing for safety. DW sent photos to Mike Newnham. MH to meet DW to look at bush, but most likely will need to be referred to County Council. DW/MH 16. Wall belonging to Mr and Mrs Smith

This has been resolved with NWBC.

17. Railings Outside Old Post Office

DW The weeds have overgrown again. Clearance is needed. DW to pass to Mike Newnham at NWBC.

18. Litter Pick Dates

The recent litter pick was very successful with an excellent turnout of volunteers. Next litter pick dates will be 13 DC February, 12 June and 16 October 2021. GH reported a windscreen and cable drum need picking up from Main Road.

19. Christmas Lights

A tree has been ordered to be placed near the church. DW to arrange necessary lights in time for 6pm on 6 DW December light switch on. DC and GH to print and deliver leaflets encouraging residents to switch their own GH/DC home lights on at 6pm and take part in a door step Christmas Carol. Covid restrictions prevent residents from attending the tree switch-on.
