### 37/06/22: TO CONSIDER AND ADOPT LONE WORKING POLICY; LONE WORKING RISK ASSESSMENT AND LONE WORKING PROCEDURES

Members are asked to consider policy, risk assessment and procedures for lone workers employed by the Parish Council.

The purpose of the policy is to alert employees to the risks presented by lone working, to identify the responsibilities each person has in this situation, and to recommend procedures which will minimise such risks. It is intended to give employees a framework for managing potentially unsafe situations.

The Lone Working Risk Assessment is used to identify and evaluate hazards present in the workplace to ensure that lone workers are safe during employment. The purpose of the assessment is for line managers to mitigate risks and prevent accidents.

**RECOMMENDATION:** That Members adopt the Lone Working Policy; Lone Working Risk Assessment and Lone Working Procedures.
