## UNDER ATTACK

Last week, I was dismayed to read that experts are wondering whether our ash trees can be wiped out by yet another invading species, this time it's the Asian Beetle.

Apparently this invading beetle arrived here fairly recently, lurking in wooden crates shipped from the Far East. It seeks out weakened trees, lays its eggs and its larvae feed on the upper layers of wood before moving inside. Given that our trees are already susceptible to the devastating ash dieback fungus, we could become a target!

So what about the state of our ash trees here in our parishes? Are they thriving or could we soon see this half-inch-long beetle in our woods and gardens in pursuit of any trees that are beginning to wilt?

It might be a good idea to venture out and check our trees for signs of die back and map where it is happening. The website <https://www.forestry.gov.uk/ashdieback> provides information on the disease and its recorded incidences in Southern England. The disease, named Chalara, causes leaf loss, crown dieback and bark lesions in affected trees. Once a tree is infected the disease is usually fatal. It was first identified in Buckinghamshire in February 2012.

Local spread up to some tens of miles may be by wind. Another pathway for the disease is movement of logs or unsawn wood from infected trees. Ash trees suffering with the infection have been found widely across Europe since 1992 when large numbers of trees were reported dying in Poland. Ash is one of the last tree species to come into leaf and by mid-June all healthy ash should be in full leaf and it is from that time onwards that we should be able to identify the unhealthy ones.

Ash is the third most common tree in UK and is easily identified by smooth twigs that have distinctively black leaf buds arranged opposite each other. The ends of their branches cluster upwards with several pairs of light green leaves. It is recognised as providing tough hardwood timber and has been used for years particularly for making tools and handles. Ash coppices well, traditionally providing firewood and charcoal.

Let me know if you suspect any infestation and we can investigate further.

## POLICE UPDATE

Dear Residents,

I am seeking any information concerning a criminal damage to a wheelie bin in Blackstocks Lane which was damaged between the 3rd and 8th May 2017, if anyone can assist please give me a call direct.

We have also had other incidents which I just would like to make you aware of. On May 3rd a suspicious man was seen riding a pedal cycle and looking into gardens and homes in Heather Row, described as of Eastern European appearance but he did not stop, speak to anyone or seen to call into a house?

We have across the area seen an increase in the burglary of homes, on the 28th a house in Old Basing was broken into and a similar crime in Rotherwick on May 5th. In Hook several garages were broken into on May 9th 2017.

Whilst these crimes are not in our direct area, we do need to remain vigilant and please report any suspicious incidents you may see.

The Constabulary is also looking to communities to help set what your local Police should be doing and to ensure that we are working effectively in the community, we need you to tell us what issues are affecting you the most. ### 'GAPS BETWEEN SETTLEMENTS

'158. The principle of Gaps is well established. Their designation aims to ensure that a sense of place is maintained for both those individual communities and for those travelling through the defined Gaps.'

### 'Policy MG6: Gaps between Settlements

'Development in Gaps will only be supported where:

'a) it would not diminish the physical and/or visual separation of settlements; and

'b) it would not compromise the integrity of the Gap either individually or cumulatively with other existing or proposed development.

'The following Gaps have been identified....

'ix. Hook to Newnham.'

Hart's Previous Local Plan identified 'Strategic Gaps' between larger, and 'Local Gaps' between smaller, settlements, hence the 'Hook - Newnham Local Gap'.

It is very good news that Hart has retained a 'Gaps Between Settlements' policy (thought it might indicated greater long term commitment to describe them all as 'Strategic Gaps'?).

While the strength of the Policy is arguable – and relative to all the other arguments which may be put forward – it has relevance and was given considerable weight by the Inspector in dismissing the Hop Garden appeal.

**It was agreed at the Parish Assembly to urge all residents, plus Ward and County Councillors, to comment on Hart's Draft Local Plan by 9th June in support of Policy MG6** in its protection of the Hook - Newnham 'Strategic?' Gap. The Gap maintains the integrity of the individual settlements and protects Newnham's rural identity. **The Consultation document is short and asks only for specific comments on individual Policies.**

'West of Hook' is not included in the site allocation for housing in this Draft of the Local Plan. But until the Plan is adopted, at best 18 months away, Hart remains vulnerable to speculative applications as below.

Hart has issued its comments on the pre-planning Environmental Impact Assessment Scoping Report produced by Armstrong Rigg Planning on behalf of Wilbur Developments Ltd. Comments include:

'The Environmental Impact Assessment (EIA) should consider the impact on any adjacent designated heritage assets and their settings... including....

'Newnham Conservation Area and the grade II listed buildings within it... Also whether development at Owen's Farm would harm an appreciation of the Newnham conservation area's rural agricultural setting.'

**It now seems likely a Planning Application – with fewer houses (possibly 650) and more green space – will be submitted over the summer. Details will be circulated as available.**

# OLD HOUSE AT HOME

## BDBC Planning Officer's Report

The case officer's report was published on the website on 15th May. It confirms that BDBC's position is to Refuse the planning application for Change of Use to Housing.

'2.2 Had the LPA (Local Planning Authority) had the opportunity to determine the application before the lodging of the appeal against non-determination, it would have refused the application.'

## **PUBLIC HEARING**

**The Public Hearing for Red Oak Tavern's Appeal will be held on 6th July 10am to 4pm.**

**This hearing will be our one and final opportunity to argue our case for the pub to the Inspector. The bigger the turnout the better.**

The Parish Council asked for the hearing be held in the Clubroom with evidence this is a suitable venue. However, the BDBC case officer believes it should be at the Civic Offices to 'ensure impartiality between interest parties' and arranged accordingly.

The Parish Assembly voted unanimously for a Clubroom hearing so residents could more easily attend.

With thanks to everyone who emailed the Inspector in support, the request has been re-referred to BDBC. The Parish Council has put the request directly to Mel Barrett, Chief Executive, and Matthew Evans, Head of Planning & Infrastructure, with the backing of Ward Councillors.

***Hopefully we'll know the outcome in a couple of weeks. But wherever it is, turnout is important.***

We can completely overwhelm the Clubroom; overwhelming the BDBC Council Chamber might be more of an ask but we can arrange lifts and car shares etc.

The Inspector will visit the Old House after the hearing so we need to make sure we have a reception committee for him there too.

More information will be circulated prior to the Hearing.

## **EXTRACTS FROM THE PLANNING OFFICER'S REPORT**

*The following extracts are selective but indicate that in several areas BDBC's conclusions should strengthen our case to the Inspector.*

'6.1.11 It is clear from the 85 public representations and the 'Save our Newnham Pub' petition undersigned by over 1200 individuals, that the change of use of the OHaH to a dwelling is strongly resisted. The LPA also acknowledges that the Parish Council and local Ward Members are also strongly against the potential loss of this Public House... The views of the local community as established through public consultation clearly demonstrate that there is a strong desire for the building to be retained as a pub.

'6.1.14 ...there appears to be no substantive evidence to show that the number of competing pubs within the surrounding area is too great for the level of local demand which seems to exist in the immediate and wider area.

'6.1.15 ...the ACV (Assets of Community Value) status is a material consideration in this assessment, as it has been demonstrated to the LPA that the pub is a valued community facility.

'6.1.23 As described within the Parish's Business Plan and clear from representations received, local residents wish their pub to be inclusive, welcoming, providing quality food and drink, catering for all sections of the community.

'6.1.28 Newnham Parish Council formally instructed Planning For Pubs Ltd who produced a detailed representation against the planning application. This representation has been accompanied by a report providing a "critical commentary" on Fleurets' viability report and to "give an alternative approach to the future viability of the Old House at Home". This report is not a formal valuation, however its author concludes that in their opinion, the Public House is viable.

'6.1.32 The Parish Council representation asserts that the local area has not seen a significant economic downturn or dramatic loss in customer base and that "an emerging groundswell of community initiatives and community operated pubs is now evident". ... this does correlate with the rise in micro-breweries across the Borough and the region as a whole, and the reported increase in demand for quality beers, wines and spirits which is also well-documented nationally.

'6.1.43 An updated working Business Plan was submitted on behalf of the Parish Council to the LPA in Sept 2016, which identified the repair and refurbishment of the pub as a key component... Whilst the actions contained within this Business Plan are dependent upon the acquisition of the building, it does demonstrate to the LPA that there is a strong and realistic desire by the local community to improve, repair and refurbish the pub in order to enhance the offer available. The Parish Council expresses the view that under a community-ownership model with a live-in landlord couple, the OHaH could be a viable proposition. This option was not discussed by either the Appellant or the LPA's appointed consultant.

'6.1.52 Given the overwhelming public response to this application for change of use, there is clearly a strong degree of support for the pub's retention. Through the efforts of the Parish Council and CPSG (Community Pub Steering Group) to date, there appears the necessary commitment within the community to seek ways and means to achieve this goal.

'6.1.54 To that end Newnham Parish Council and the CPSG has commissioned a Working Business Plan which outlines how a loan available to the Parish Council via the PWLB (Public Works Loan Board) would in the words of the Parish "secure the future of the OHaH as a thriving rural business and social hub of the village".

'6.1.55 It is clear that such a plan is not without risk and substantial upfront costs. Therefore this business plan cannot be regarded as definitive. However, the Parish Council and CPSG already seem to be demonstrating a degree of commercial endeavour and appear flexible to those likely changing variables over time.

'6.1.56 The LPA cannot say with any certainty that there wouldn't be a reasonable prospect of the OHaH becoming a viable business in the future... The LPA cannot overlook the aspirations and imagination of a community led venture of the type promoted by Newnham Parish Council and the CPSG... Furthermore, there are a range of other organisations like CAMRA and the Public Loans Board which are likely to lend support and assist in practical ways to bring about a reasonable prospect of viability under an alternative model....'

# Letter from the Benefice Ministry Team

Pentecost comes round again at the beginning of June—with a Benefice-wide service at Herriard at 7pm on 4 June. Being old-fashioned, I am happier calling it Whitsuntide, the old English name recalling how new Christians used to come to church for baptism wearing white garments. Pentecost is the Greek name (meaning fiftieth) for the Jewish Feast of Weeks on the fiftieth day after Passover. People were then invited to give a free will offering of produce to God at a sort of early harvest festival. It was here, fifty days after Jesus had been crucified, that his disciples had that extraordinary experience when the Holy Spirit came upon them “like the rush of a violent wind”.

I think all of us find this a little puzzling. Who is the Holy Spirit? How does he show himself in the modern world? There's a story in the Old Testament which I think helps. Around 600BC God's people were in a mess. They had tended to forget about God. Nebuchadrezzar (or however he spelt himself) had overrun the land, and the cream of the people had been led away captive over the desert to exile in Babylon. The people had lost their liberty, and they had lost their land. Had they even lost their God?

Then the prophet Ezekiel had a vision of a desert filled with dry bones—all that remained of God's people. In the vision God said to the bones, “I will make breath enter you, and you will come to life”. The Hebrew word for “breath” also means “wind” and “spirit”, and as God breathed his spirit upon the dry bones there was a wind and a rattling sound as the bones began to come together, and as his breath entered them they came to life and stood on their feet. What had been lifeless and useless became a vast army. You can read the story in Ezekiel, chapter 37.

The Holy Spirit works today in much the same way, only with a different sort of drama. Before he was crucified, Jesus promised his followers that he would pray God to send the Holy Spirit as a gift to be with them for ever. The Holy Spirit can and will enthuse us and energise us and encourage us and enable us, as he did them. He is there for the asking, and puts the sparkle into life, as countless generations have found throughout the ages. In the Bible the Acts of the Apostles tells the story of the new Christian church, beginning at Pentecost when the disciples, a useless and dispirited bunch, rather like those dry bones in the desert, were suddenly filled with the Holy Spirit and at once became new people, full of life and enthusiasm. What happened to them can—and does—happen to us.
