Engineering operations comprising the laying of roadstone for agricultural road and installation of cattle grid (retrospective) Land at Kelmarsh Road, Arthingworth

2 letters of objection were received from residents.

This retrospective application bears no resemblance to the previous permitted application (DA/2013/0406) and the Parish Council object for the following reasons:-

- 1) The wall is on a flood plain as shown on the ordnance survey maps.
- 2) Visibility splays these are not adequate and make the entrance dangerous. The permitted application (DA/2013/0406) had to be amended to achieve a 43 metre visibility splay which has not been complied with.
- 3) The large plaque embedded in the wall in not in keeping with the surrounding area and is inappropriate in a rural situation.
- 4) This retrospective application is for an agricultural track but the sign embedded into the brick wall implies it is an entrance to private grounds. The Parish Council would question whether this is agricultural usage.
- 5) The surface of the track is loose stone which will spread to the road. The conditions of the permitted application state that the track must be tarmac for a distance of 10 metres into the site from the highway boundary to prevent spread of loose material.
- 6) Without prejudice can the planning authority please impose a restriction in the future of further signs, hoardings, flags etc.
