I also enclosed a copy of a letter which I have sent to each of the persons named in the Notice in which reference is made to the procedures for the making of the declaration of acceptance of office and notification of registrable interests. No doubt you will be in touch with the persons named in the list in due course.

Where the number of nominations falls short of the number of vacancies, Section 21(a) of the Representation of the Peoples Act 1985 states that your Council may co-opt any person or persons to fill the vacancy or vacancies remaining unfilled.

The same Section also states that the District Council may exercise the powers conferred by Section 39(4) of the Principal Act (power of District Council by order to do anything necessary for the proper holding of an election etc). in relation to any such vacancy or vacancies as are not so filled. However, the powers shall not be exercised before the expiry of 35 days (computed according to Section 40 of an election etc.) in relation to any vacancy or vacancies as are not so filled.

I think it would be advisable if your Council were to consider co-option and make any such appointment before **Friday 24 June 2016** (expiry of 35 days). I should be grateful if you would advise me soon after this date the current position on your Council and the name(s) of those co-opted (if any). The Borough Council will then decide what action to take if vacancies still exist.
