27 PLANNING

27.1 Parish Planning applications

i <u>20/01910/FUL</u> (Validated 13 Aug 2020) Cherry Tree Farm, Chandlers Green. Erection of an agricultural workers dwelling with associated landscaping and car parking.

Applicants appealed the June application on non-determination. New application is a duplicate of the previous – submitted so Case Officer can continue to consider – as consideration of the previous one automatically cut off by going to Appeal.

Case officer Peter Lee has agreed to proceed on this basis. New application has been accepted providing the appeal is put on hold. According to case officer, the sticking point is the business case. This has to be proved for policy requirement. Applicants have been there 15 years but only showed a small profit for last three.

The case officer considered that there is no benefit in the Parish Council submitting a further response. It is the business information that is crucial. He may be minded to approve if received the supporting accounts. If not will refuse.

It seems the SANG issue can be overcome. Hart not considering new SANG until October meeting, but there are means of achieving via other Districts in the Housing Market Area.

27.2 Central and Eastern Berkshire (CEB) Minerals and Waste Plan

The plan is now at Reg 19 Proposed Submission consultation.

This was briefly discussed at July 2020 meeting relation to application for the 'Swallowfield Gravel Pit'. Also re Hants' 'Duty to Co-operate'.

Then at Reg 18 consultation – the Plan had 'lost' the site at Bridge farm and so considering Swallowfield site 'Land West of Basingstoke Road' to in-part replace it.

NOTED Re the Swallowfield site, it had been noted in discussion that so much mitigation required that the site would cost itself out... It seems this may be the case and no decision has yet been taken. According to the sites statement of July 2020: 'Outcome: To be taken forward to Sustainability Appraisal stage for a full assessment.'
