# MINUTES OF THE MEETING OF BARROW PARISH COUNCIL HELD ON TUESDAY 21<sup>ST</sup> January 2020 at 6pm IN THE VILLAGE HALL WILLEY

#### 1. PUBLIC PARTICIPATION:

Members of the public will have the opportunity to raise Parish matters between 6.00 p.m. and 6.10 p.m. Three members of the public were present. The raised an issue about the pavement/footway on Bridge Road from Spout Lane Junction on the righthand side going towards Telford.

- **2. ACCEPTANCE OF APOLOGIES:** All were present no apologies.
- **3. TO RECORD THOSE MEMBERS PRESENT:** Councillors Downes, Knott, Churchill, Skinner and Whiteman. Also, present Shropshire Councillor Turner.
- 4. **DECLARATIONS OF INTEREST AND DISPENSATIONS:** None.

#### 5. MINUTES:

To confirm the Minutes of the meetings held on  $19^{TH}$  November 2019. It was RESOLVED to sign and approve the minutes of the meeting held on  $19^{th}$  November 2019.

## 6. REPORT BY SHROPSHIRE COUNCIL MEMBER:

To receive a report from the Shropshire Council Member. Shropshire Councillor Turner reported on the performance of Shropshire Council across most of its services. The one service that is causing most concern is Highways. There are major and chronic problems across his ward. He is using every device available to him and has received some assurances things will start to be addressed soon. He did point out the condition of the footway down to Telford on Bridge Road a month or two ago but will check on progress. He has also received an update on stability issues on Bridge Road. Progress should be made soon. The Ironbridge Power Station site has two planning applications live at present one for outline permission for up to 1000 homes and a new centre. The other is for mineral and aggregate extraction. His next advice surgery will be 25<sup>th</sup> January 2020 at Shipton village hall.

#### 8. PARISH ALLOTMENTS.

- **a.** A plot holder has asked about a mature muck pile. Good idea but there are environmental issues involved in storage of muck. Leaching, smell, flies and health and safety. There are options such as purchase in bags and stored that way. It was RESOLVED to suggest a supply to the plot holders who can arrange collection themselves.
- b. Damage to the sign on the gate to Floyer Hall was reported to clerk. Noted no action.
- c. A request for an update on the fencing between the allotments and neighbour property has been responded to. Noted no action.
- d. One of the larger plot holders has given notice and will be leaving before the spring growing season. This plot can be divided into two once the current holder leaves.

- e. The waiting list has 6 people on it.
- f. Clerk to start investigating tree works and hedge cutting.

- a. Issues to be reported to Shropshire Council. Clerk to report a number of overhanging hedges in Benthall. Clerk to report condition of the highways around Willey and The Smithies.

  - 19/00509/MAW Proposed Quarry to the east of Much Wenlock Road Buildwas. Phased extraction and processing plant and ancillary infrastructure temporary store of minerals utilisation of existing rail siding and creation of new access road...... It was RESOLVED to object to the application because of impact on the highways leading to the parish. Including overuse of the minor roads leading between the parish and the site.
