4 PUBLIC SESSION Questions raised regarding:

4.1 Langdale, Woods Lane

AGREED

New owner of Langdale Mr Justin Knott attended the meeting to advise the Parish Council of his development plans.

The Parish Council commented that:

- 1. The Parish Council is in principle not in favour of backland development increasing housing density in a rural conservation area. The Parish Council has previously objected to backland development in Woods Lane.
- 2. Road safety is an issue on Woods Lane and more houses increases the traffic which increases the risks.
- 3. The Parish Council is approachable and open to discussion and generally welcomes development that is in keeping with and sensitive to the area.
- 4. The Parish Council appreciates Mr Knott speaking with them and with neighbours. Mr Knott explained his intention to submit a new planning application for a central access drive with two houses at the front either side the access and two at the back, following a meeting with BDBC planning (Brian Conlon). The implication was that the proposal may be considered favourably providing conditions regarding to relationship with neighbouring properties are adhered to.

As a new application is to be submitted, the Chairman said that the Parish Council would formally respond to the application once submitted. While explaining its position in principle, the Parish Council could not comment specifically on a proposal before it is submitted. The Chairman thanked Mr Knott for taking the trouble to attend the meeting and advise the Parish Council of his plans.

6 PLANNING

6.1 Southlea Meadow

It is apparent that Thakeham Homes are taking every opportunity to strengthen their case and seem content with delay. The case officer has to be careful to consider any evidence they continue to present, or risk a claim that the final decision is unsound.

6.2 Neighbourhood Planning

The Parish Council is promoting the development of a Neighbourhood Plan, but needs people from the community to support.

6.4 Trees

From discussion with Tree Officer David Harris it is evident that a programme of seeking new tree preservation orders (TPOs) is not practical from BDBC's point of view due to the administration involved and is usually only considered if the tree is under threat. The recent refusal by the Tree Officer of applications for works to TPO trees indicates the classification does provide some initial level of protection.

The BDBC Tree Officer supported the concept of a catalogue of notable trees in the Parish, but Tree Warden Alison Mosson commented that there are so many.

AGREED

The Tree Warden does her utmost to work towards safeguarding the trees in the Parish and has the full support of the Parish Council.

6.5 Motorway Service Station proposals

J6 (Hackwood Estate land) – the proposal is for access from both directions. It seems the prevailing view is that the proposals will impede motorway traffic flow which the recent hugh investment at Blackdam was designed to improve. No planning applications have been submitted to date.

6.6 Tamar AD Plant (Farleigh Wallop)

Cllr McNair-Scott is on the liaison panel for the Anaerobic Digester and commented that Tamar really are trying very hard to comply with designated traffic routes and restrictions and are sacking drivers who don't comply. There is a numberplate recognition devise on the roundabout by the school.

Cllr McNair-Scott commented that smell from the plant was a problem (in theory not supposed to be). The plant was originally allowed at Appeal much due to Government Policy support but doesn't make sense to be so close to the Herriard plant.

7 COMMUNITY MATTERS

7.1 Village Hall Storage Shed Proposals

CONFIRMED As Custodian Trustee of the Village Hall, the Parish Council fully supports the Village Hall Committee's plans for a new storage building. The Parish Council supported the planning application recently approved by BDBC.

AGREED The Parish Council fully supports the Village Hall Committee's plans to seek grant funding for the project which is likely to cost c £50 - £60k.

Thanks to Alan Tyler for mowing. The pond area needs an October 'tidy-up'.

ACTION | Parish Council to undertake – maybe two to three hours' work.

7.5 Litter & Bins

Thanks to BDBC team bins continue to be emptied regularly.

7.6 Bus shelter update

Roofer unable to give clear estimate until roof cleared of vegetation.

Lengthman Joe Nodes scheduled to do this end October / start of November.

Agreed with Cllr McNair-Scott that the re-roofing project would likely be suitable for an application for funding from her devolved budget.

8 TRAFFIC AND TRANSPORT

8.1 | Community Speedwatch

It was noted at the last meeting that Speedwatch volunteers are bound by Police guidance for insurance purposes and Hampshire Constabulary presently requires a minimum of three people at one time to undertake Speedwatch. There has been discussion about two people doing a Speedwatch session without taking numbers.

AGREED Confirmation of emailed agreement and advice from the Parish Council 10th August 2017: As the equipment belongs to the Parish Council, altogether the Parish Council wishes to support SpeedWatch sessions, it is unable to sanction use of the equipment without the users being insured.

8.2 Speed camera signs

ACTION Clerk still to liaise with Highways (BDBC). Previous contact Andrew Kettlewell has taken up a new post and forwarded enquiry. Cllr McNair-Scott confirmed that Mandy Ware is the correct contact.

8.3 Speed Indicator Devises

With thanks to Wendy Simson, Clerk to Candovers, Clerk has circulated costs and supplier details for speed indicator devises (SIDs) recently purchased by Preston Candover and Nutley Parish Council. .

AGREED To consider the speed camera signs before considering SIDs.

8.4 | Bus Service

Regarding recent further cuts to the rural bus service, particularly opposed in the Candovers, Cllr McNair-Scott said the reason was withdrawal of all subsidy from Central Government. Subsidies have been reduced by half a £billion in the last five years. The buses fulfill a social need but if there is no money, bus routes where few people actually use the buses can't operate without subsidy. There is no hope in arguing to reinstate the service. Lynda Plenty commented on the increasing social isolation resulting from withdrawal of services.

Cllr McNair-Scott suggested the Parish Council consider the 'Good Neighbour Scheme' which has groups across the County. Not a replacement for a bus service as such but facilitates an opportunity to give and receive any form of help in the community. The Parish Council agreed that this was its remit and Cllr McNair-Scott will set a process in motion to organise a presentation from a Scheme representative.

ACTION | Clerk to follow up and arrange.

9 HIGHWAYS

9.1 Footpath 1 Hazel Metz confirmed that vegetation along FP1 has been cut back. (FP1 is on the Hampshire County Council Countryside Services' (HCCCS's) local access 'priority cutting list' scheduled for cutting in July.

9.3 Lengthsman tasks

AGREED

Lengthsman Joe Nodes is scheduled for a day in Cliddesden end October / start of November (see 7.6 above). Clearing the bus shelter roof will be priority but beyond this, agreed Joe will concentrate on re-clearing the grip into Southlea Meadow and clearing the mouths and surrounds of soakaways on Farleigh Hill and above Church Lane opened out with digger in July.

9.4 Woods Lane

Cllr McNair-Scott said she would raise the issue of the trees and bushes encroaching along the unrestricted speed limit stretch of Woods Lane to the motorway. HCC is the landowner (land purchased when M3 constructed and Woods Lane diverted).








Appendix II.II - CLIDDESDEN TREE PRESERVATION ORDERS
