SDNP/23/02360/HOUS - Meadow House, East End, West Meon, Hampshire, GU32 1LS. Replacement of existing 3 foot high 5 bar wooden drive gate with a wooden six foot high pair of gates plus replacement of existing 4 foot high wooden gate posts with 6 foot high wooden gate posts. All new items being made / clad in Iroko or Oak. APPROVED.

Proposed: that the PC agrees upon the most appropriate actions to be taken in dealing with the non-road-legal vehicles currently parked in the Recreation Ground carpark.

2463 Recreational Ground Car-park Use Policy

Proposed: that the PC should, in collaboration with the Village Hall Committee, draw up a policy to direct the use of the Recreational Ground car-park.

2464. Over-flow Parking at WM Village Hall

Proposed: that the PC discusses the possibility of using a section of grassed area at the rear of the VH for over-flow parking for circa 12 vehicles (grass mats to be used to protect the grass).

2466. Deployment Dates for Temporary Speed Indicator Device

Proposed: that the PC agrees on suitable dates (in blocks of 2 weeks) to hire the TSI device from Corhampton and Meonstoke PC.
