30/19 Members of the Public:

Cllr N Stephens reported that a small commemorative statute had been presented to the Town Council by a resident of Craven Arms who had recently visited Belgium. The statute is in memory of the 6,000 World War 1 soldiers who had died in Belgium and had been presented to the Town Council it is suggested that the statue be put on display at the Craven Arms Discovery Centre or Stokesay Church.

34/19 Chairman's Items:

The Clerk reported that as there had been no response to the Notice of Vacancy for a Town Councillor the Town Council were now able to co-opt a person to the vacancy. The Clerk will advertise the vacancy on the Parish Council Notice Board and Website.

24/19 Highway Items:

Cllr N Carter reported that the planters at the Station were beyond repair and that National Rail were considering options available.

Cllr D Evans will report the issue of overgrown weeds in Market Street Craven Arms The Clerk will report streetlight out adjacent 15 Greenfields Road Craven Arms.

25/20 Amenity items:

a) The Clerk reported that work on the upgrade to the CCTV system along Shrewsbury Road by the Corvedale and Clun Road Roundabouts Craven Arms which have currently come to a stop due to issues with placing equipment on Highway Lighting Columns.

Although there is existing equipment on two Highway Lighting Columns a safety alert has been issue by Highway England were, they have experienced several lighting column failures associated with columns were unauthorised equipment has been installed. Highways England have recommended that existing lighting columns with attachments should be reviewed for adequacy.

On behalf of the Town Council Shropshire Council are seeking clarification regarding the proposed new CCTV/VRN system for Craven Arms for which the Town Council have received a grant from the Police and Crime Commissioner towards the works.

- The Clerk will make a further report to the next meeting were an alternative solution may have to be considered for the installation of the CCTV facilities.
- b) The Clerk reported that Shropshire Council Countryside Maintenance Team had submitted a quote of £1,234 plus VAT for the repairs to the steps and handrail which border the River Onny in the Car Park//Picnic Area Corvedale Road Craven Arms.

It was proposed by Cllr R Conway and seconded by Cllr S Demos and agreed by the Town Council that the quote of £1,234 be accepted from the Countryside Maintenance Team. The Clerk to obtain some guarantee for the life of the works.
