**Minutes of Full Council held on 08<sup>th</sup> June 2023 at Cerne Abbas Village Hall**

**Councillors present:**

There were 13 members of the public present including representatives from Applecourt and the Up Cerne estate.

Cllr Jill Haynes (Dorset Council)

**1. Apologies for absence**

Cllr's Prowse, Muskett, Crosbie, and Beresford sent apologies.

**2. Declarations of pecuniary and other interests**

Cllr Horsington declared an interest in any matters to do with the allotment field.

Cllr Horsington declared an interest in agenda items 9f 2 and 3.

Cllr Paul declared an interest in agenda item 9f 1.

Cllr Bishop declared an interest in agenda item 9f 1.

Cllr Bishop declared an interest in agenda item 15.

**3. To confirm the minutes of the Parish Council Meeting held on 11<sup>th</sup> May 2023**

These were approved as a true and accurate record of the meeting.

**To confirm the minutes of the Annual General Meeting held on 11<sup>th</sup> May 2023**

These were approved as a true and accurate record of the meeting.

**4. Matters arising from previous meeting**

There were no matters arising.

**5. Update from the Chair**

The Chair thanked all those who filled in during his absence along with those who continue the hard work throughout the Cerne Valley.

**6. Public Discussion Period**

There were no comments at this time.

**7. To receive a report from the Dorset Council**

A report had been received and distributed,

Cllr Haynes was asked why the local plan was not going to be ready for 2024.

The short answer being the that after the public consultation of 8K people, and the censuses was the public were not happy. To that end, DC are looking to central government to look at a different way of working with a view to completing the Local Plan by 2026.

**8. Financial update**

**a. Payments for authorisation**

There were **14** payments (**PV's 21-34**) totalling **£ 5753.92** that were authorised and approved.

Advance approval was given to pay a deposit of legal fees of up to £2K, to Porter Dodson on production of an invoice.

The Clerk also confirmed that income was higher than expected, but a full budget report would be given at the next meeting.

**9. To receive committee reports and to agree action(s) in response to proposals and repairs**

**a. Allotments**

Cllr Keating confirmed that 2 plots were now available.

A site visit by Wessex Water identified that no check valves where in the taps.

New ones had been purchased and where to be installed by the end of the month.

**b. Burial Ground**

Porter Dodson were appointed as legal representation for the purchase of the Burial Ground Extension.

Members agreed to reasonable fees for fees up to £2K for seller and purchaser, with disbursements not to exceed £500, without consultation.

Funding from Burial Ground Reserves.

**c. Car Park**

There were no matters at the Car Park.

**d. Children's Play Park**

The recent inspection report picked up no new issues.

**e. Footpaths and Environment**

Members updated on the following:

**f. Planning See Annex A**

**10. To form a Working Group to discuss the road management in Cerne Abbas Village Centre**

Members agreed to form a Working Group, consisting of 4 Councillors, businesses, and members of the public.

The aim would be to identify the primary issues and brain storm solutions that would satisfy the majority of the Cerne Abbas, and could be feasible for Dorset Council to achieve.

**11. Procurement of Village Gateways**

This item was moved to the next meeting.  
Members requested full costs that included installation.

**12. Closure of Coronation Reserve**

Members were satisfied that all expenditure had been accounted for.  
The reserve was closed and the remaining funds of £ 160.89 was transferred to the General Reserve.

**13. Replacement posts on Duck Street**

Cllr Keating requested that some of the posts had signs of rot.  
Cllr Horsington confirmed that some of the original purchases were stored at his farm.  
Authority was given to purchase some white paints and sleeves from the F&E budget.  
Once ready, the Clerk would ask DC Highways to install.

**14. Renewal costs for defibrillators**

Cllr Keating reminded members that the defibrillators were on a 4-year lease.  
He wished to ask how they would be paid for in the future. Options included:

Pay from General reserve  
Increase Precept  
Use excess budget(s)

It was agreed to create a specific reserve and use the excess of the Coronation to start the fund.  
Further discussions would be had at Governance and at end of year accounts.

**15. Planting of invasive species by pond on Abbey Street and the obstruction by other plants of outflow from the pond**

Cllr Bishop raised concerns as to regards the planting of Gunnera by the Pond watercourse.  
It was felt that this plant which grows very big and has prickly leaves, could potentially cause blockages in the drainage system of Abbey Street when it sheds its leaves.

It was agreed by all that prevention was better than cure and requested that the Ward Councillor should contact the Local Lead Flood Authority at Dorset Council to seek advice on this matter.

I'm delighted to inform you that following our entry for three categories at this year's contact centre awards we reached the **final for all three** categories, and we **won two**:

- **Best Customer Engagement:** this submission featured our Ukraine Response
- **Contact Centre of the Year – In House:** this submission celebrated all the achievements of customer services team including our central access team, adult access team, out of hours team and rapid response.

The competition at SWCCF is a mix of public and private sector. The private sector membership being much more heavily subscribed to the forum than public sector, so we were up against companies like EE, Ageas, UCAS, RAC, Stannah Lifts and many more

The [Customer Services](#) team offer support over the telephone, webchat, email, social media channels, SignVideo and at face-to-face Customer Access points. They are the 'front door' for Dorset Council, providing support for residents on behalf of over 60 departments across the council.

They also support a huge range of other services, from offering pre-eligibility checks for social care, processing Blue Badge applications, and providing emergency out-of-hours cover, to managing the Homes for Ukraine Scheme, involving the coordination of Welfare Checks, Housing Standard reviews, DBS checks and Host payments

## **SEND & DISABILITY – CHILDRENS'SURVEY**

PLEASE NOTE – this survey has been extended to the 10<sup>th</sup> July so still time to get involved!

Parents and carers of children and young people with special educational needs and disabilities (aged between 0 and 25 years old) are being asked to complete a survey to find out their experiences of education, health and care services and support over the last 12 months. The results of the survey will help to decide what changes we need to make to the services we provide.

The Parent Carer Forum said: 'Through our partnership with Dorset Council and NHS Dorset we strive for Dorset's children and young people to realise their full potential and be the best they can be.'

## **RECORD NUMBER OF AFFORDABLE HOMES BUILT IN DORSET**

Record numbers of affordable homes have been built for Dorset residents in the last financial year as we respond to the huge need for affordable housing.

Working with Registered Provider Housing Associations, a total of 664 new affordable homes, including a range of tenures, such as rented and shared ownership, including houses for local, key workers, were built by Housing Associations, or acquired by the council in the year to March 2023.

This is the highest figure since the unitary authority was created in 2019 and represents a rise of 135 additional houses and flats compared with the 529 created in the year to March 2022. In the year to March 2021, just 301 new affordable homes were built.

## **SAVE MONEY ON PARKING**

With recent rises in some public car parks in busy tourist areas, Dorset Council is urging people to check the cost benefits of its permits.

The cost of its permits has been frozen this year, with the Short Stay and Flexi car park permits offering savings for residents and workers:

### **SHORT STAY**

Two hours parking every day in most of the council's car parks.

Cost: £78 a year

#### **How the savings add up:**

If used for 2 hours a week = £1.50 a time.

If used for 2 hours daily = just over 21p a time.

### **FLEXI**

For residents, businesses and workers. Unlimited parking (or up to two hours in car parks where there is a maximum stay) in the majority of the council's car parks 7 days a week.

Cost: £25 if purchased for a month, or £260 for 12 months, the equivalent of £5 a week for all-day, year-round parking.

While the council has introduced seasonal increases at car parks in busy resort and seafront areas, prices for tickets in other nearby car parks have not increased.

For example, in Weymouth, Governors Lane, Nothe car park and the former council offices car park at North Quay park charges remain unchanged.

## Proposals from the Cerne Abbas Traffic Management Working Group

The CATMWG met on Thursday 29<sup>th</sup> June at 6pm at Abbotts Tea Rooms

This was attended by 4 members of the public, 3 business owners and 3 Parish Councillor.

### Background

Some 2 years ago, a complaint was made a business owner about her property being consistently hit by vehicles (normally buses).

Actions from the meeting with Dorset Council resulted in the enhancement of line marking, a request for the buses to be rerouted, and the deployment of cones to emphasise the no parking area.

### Current situation

Over the past few months, the Parish Council has received numerous but varied complaints about traffic flow through the centre of the village.

It was agreed at Full Council to hold a CATMWG to establish if there were issues and what realistic proposals could be put forward to counter them.

### Speed

This subject expanded to the perimeters of the village as well, with people stating that traffic far exceeded the 30mph from all entries of the village (Duck Street, The Folly, Piddle Lane, and Alton Lane). The focus centred on the speed of tractors. It was suggested that the problem was one of a precepted speed, as large vehicles travelling at 30mph in a confined space would feel much quicker than the actual reality.

#### **Proposal 1**

That speed wires be installed (£330.00), in the village centre, to provide the data, will allow the CVPC and village to take any action, or to make recommendations going forward. I.E. 20mph speed limit.

### Parking

This was broken down in four different areas:

- a. Short term parking on double yellow lines

It was agreed that this was predominantly locals, using the shop.

#### **Proposal 2**

That a parking bay with a time limited (20 minutes maximum stay) be inserted outside the shop.

- b. Parking of delivery vans / lorries

It was agreed that these take a longer time. Proposal 2 would enable vans / lorries to park in this bay(s) and therefore not effect the flow through the village centre.

- c. Long term parkers (day trippers / overnigheters)

All agreed that no law was being broken, but better signage would allow visitors to be guided to the public car park on Kettlebridge thus assisting with the short-term parking issues as previously mentioned.

### **Proposal 3**

**That the Parish Council place 'Public Car Park' signs on the finger post on Long Street directing visitors to Kettlebridge.**

**That The New Inn is approached requesting that their Car Park is signed more than present.**

- d. Parking on pavements.

Both inappropriate parking and parking on pavements are only unlawful if deemed that they are causing an obstruction. In this case the matter must be reported to 101.

**No proposal put forward.**

### **Cones**

Most complaints were the poor aesthetic nature of the yellow cones within the conservation area in the AONB.

However, none of the WG wished the cones to be removed as it was believed they did help with traffic flow within the village centre.

### **Proposal 4**

**That the cones remain until other measures were actioned.**

### **Other matters**

All agreed that any matters must ensure that the bus continued through the village centre.

All agreed that any measures would be futile against bad and poor drivers.

All agreed that without enforcement, the double yellow lines seemed pointless.

### **Other proposal for consideration**

- a. The insertion of a mini painted roundabout could focus drivers not to park or drive around the area
- b. A one-way system from Mill Lane junction along Duck Street into Long Street would provide better traffic flow and negate the need for large vehicles to turn left into Duck Street from Long Street.
- c. Extension of yellow lines on Duck Street would provide a wider turning circle for turning in from Long Street.
- d. Signage on The Folly stating weight restrictions for large vehicles.
- e. To request Dorset Council to deploy parking enforcement officers to Cerne Abbas on a regular basis.
