 - a) Parking Issues Ragnall PC Bill Bailey explained his findings about the parking issues at Ragnall. Referring back to his report last month the situation remains the same. He stated that residents of Roberts Close do have their own drives but still park on the slip road to Roberts Close. The Chairman said how this causes difficulty with manoeuvring at Roberts Close because of the parked cars. No further action will be taken.
 - b) JG Pears (Newark) Ltd.
 Environment and the Planning Departments officers from BDC had held a meeting at Normanton to voice public opinion about the proposed planning application to extend the plant. The plans propose to build a heat and power plant, install auxiliary boilers and silos, build new office premises, additional trailer/car parking facilities and other associated works. A second application proposes to build higher chimneys and install a lid for the existing peat beds. PCIIr M. Barden attended the meeting and reported back to the Parish Council stating that the meeting was well attended and raised people's concerns about the increase in traffic, the smell, quality of life, standard of living and the conduct of lorry drivers, much of which affects many other villages away from Low Marnham. The Clerk had requested a copy of the planning application in order for the Parish Council to convene and discuss the implications for Dunham and District parishes.
 - c) Village signage
 The primary school children had submitted their designs for an emblem for the village signs. The pictures were displayed at the meeting and the Parish Councillors chose one for each village. It was decided that the efforts made by the children should be awarded and 4 gift tokens which will be presented at the school. It is now hoped that the application for signs is successful.

The Planning Application for extensive works at J. G. Pears had been received from Bassetlaw District Council and discussed by the Parish Council at a special meeting held on 15 February to discuss the implications and the impact these proposals would have on all four Dunham and District parishes.

As a result it was deemed necessary to hold a public meeting to air the views of the public, this was arranged for 20 February 2012.

The plans proposing to build a heat and power plant, install auxiliary boilers and silos, build new office premises, additional trailer/car parking facilities, build higher chimneys and install a lid for the existing peat beds and other associated works were displayed at the meeting.

The meeting was well attended and raised people's concerns about the increase in traffic, the obnoxious smell both from the plant and from passing vehicles, the inability for a rural setting to cope with such a dramatic change which would affect their quality of life and standard of living. The Clerk provided the Parish Council with a comprehensive report from the public meeting which covered all the points of objection. This was approved by the Parish Council and a copy of the report will be sent to the Planning Department. **Action: M. Annable**

- b) <u>Village signage</u>
 - The application for village signs was successful and they are currently in the process of being manufactured. They will display the designs created by the Dunham on Trent Primary School children. A draft picture sent to the Clerk by e.mail from the L.I.S. co-ordinator and was viewed at the meeting. Minor changes were discussed and agreed and the Clerk should contact the co-ordinator, note the changes and give the go ahead for the signs to be produced. **Action: M. Annable**
- c) <u>Dunham on Trent Church</u>

 A letter had been received from Bassetlaw District Council which regarded salvaging a post threatened with loss due to budget cuts for a Rural Officer. The letter was read out to the meeting. The objective to financially support this post through donations from Parish Councils caused a mixed reaction from Parish Councillors. One view was to equate the donation in terms of an investment should the Rural Officer secure funding for the Parish by way of obtaining substantial grant amounts. In opposition it was stated that the Parish Council should not be asked to fund employment in this way and the question was raised as to whether or not this request is a legal proposition. No decision was reached.

- d) Highways Parish: The Chairman referred to the change in steet lighting confirming that lights will be turned off from midnight to 5.30 am in residential areas, lights may be dimmed on through routes when there is less traffic and a small number of lights in rural areas are being switched off. The response from Councillors varied some felt that the changes could lead to an increase in crime others felt that the darkness could be a deterrent to crime. The erosion of the road sidings between Ragnall and Fledborough has been investigated by Nottinghamshire County Council and found to be in acceptable order at this present time, however, the road will be monitored for further wear and tear. A letter received from Cottam Power Station highlighted the approved routes for HGV's and disputed whether or not drivers were taking short cuts through Ragnall and in order to address the complaint in detail further information about individual vehicles would be required. Notwithstanding this, reminders of the designated routes will be sent to each company from Cottam Power Station.
- e) Footpaths & Parish Lanes: The footpath between Upper Row and Laneham Road is to be cleared initially by Nottinghamshire County Council Highways, the Clerk will also notify the farmer and request the clearance of hedging debri when the hedge is being cut. He spoke of the difficulty in trying to prevent this type of crime and is hopeful that the measures now in place will deter this happening again. The Police are aware and are pleased to see that security cameras are in place and they are keeping a close watch on the Hall and the surrounding area.
 - d) Roaming livestock
 It was reported that large game birds are crossing the road on Main Street,
 Ragnall. Motorists have had to swerve to avoid the birds and this could
 potentially cause an accident. The Clerk was asked to write a courtesy
 letter to the owners of the birds at Ragnall House in the hope that the birds
 can be kept enclosed in the grounds of the property. Action: M. Annable
 - e) Communication discrepancy from NCC Highways Department
 The Clerk informed the meeting about a misunderstanding with regard to
 the proposed road works recently carried out on the A57. A Bulletin Notice
 which was displayed in each Parish notice board had stated distances of
 600 metres in a westerly direction and 870 metres in an easterly direction.
 The Clerk was of the understanding that this was to be the length of road to
 be resurfaced, however, after several phone calls it was established that
 the distances quoted referred to the Traffic Management, i.e. cones and
 lights, to be set in place to resurface the crossroad area only. This had
 caused a delay in the reporting of the poor condition of the road between
 the cross- roads and Darlton. This defect has now been reported.

Planning Application in Fledborough (12/01042/FUL

A Public Meeting was held on 19.07.12 regarding the above. The Parish Council had been approached by members of the public showing concern about the intentions of this planning application and the potential impact this could have on the local

community. Initially the meeting was arranged for the Parish Council to consider the effects of the application and familiarise themselves with the details. However, the response from the public was intense and rumours were circulating without foundation and on the strength of this situation getting out of hand the public were invited at the eleventh hour. The applicant, John Gifford and his colleague, Damien Napier had contacted the Chairman during the day and had also been invited to attend. 15 members of the public were present.

The purpose of this planning application is for Change of Use and not for alterations to the buildings

The applicant, John Gifford and Damien Napier informed all present about the Caldecott Foundation and the reasoning for wishing to move to this area. Now in its' centenary year the foundation owns 4 homes nationally and houses children from abused backgrounds and places them in a safe environment. The objective is to educate and guide the children to lead a normal life and become an accepted part of society. It was agreed that the children do have challenging behaviour which was one of the major concerns expressed by the public. Also discussed was the fact that the children are not secured and there is a probability that they could escape the grounds of the home and cause disruption in the area, vandalism to properties and fear to local residents. This matter was strongly defended by the applicants who stated that these children are tended to by highly trained staff around the clock, and although there is always the possibility of escapism, it is unlikely to happen, and if it did, the location and grounds around the home would enable the recapture of the child to be much easier. There are risk assessment programmes in place to monitor these situations.

The maximum number of children resident at the home at any given time is ten but is very often less. Referrals would be received from Lincolnshire and Nottinghamshire County Councils for placements and the children are then assessed over 3 and 6 month periods.

The outcome of the meeting was not conclusive, but the presence of Mr. Gifford and Mr. Napier was appreciated and they had given the public a better understanding of the situation.

The main objection to the application was that the road leading to the property is not suitable and that the increase in traffic flow would cause difficulties.

The Parish Council will object to this application on the grounds that:-

- The road leading to the home is not suitable for any increase in traffic movement. There are no passing points and there are ditches on either side.
- The area is unsuitable for the setting of a children's home because of dangers posed to them, i.e. pump station, the river Trent, and electricity pylons are close by.
- The neighbouring properties and the residents in the area feel vulnerable.

Several letters that had been sent to Bassetlaw District Council to oppose this application were handed to the Parish Council for their records.

Barden reported that there were 850 objections recorded to date covering the initial application and the submission. The Environment Agency feel it is primarily an issue for them to deal with not Bassetlaw District Council. The number of lorries to be used in transporting waste material remains controversial.

b) High Marnham

A letter received from the National Grid informed the Parish Council that the sub station at High Marnham will not be replaced for the foreseeable future.

c) Pilot Lengthsman Scheme

The Parish Council discussed the progress of the scheme and viewed a number of before and after photographs supplied by Mr. Gaisford. The improvements to the local area are significant. The Clerk reported that a survey regarding the scheme is due to take place later this week, whereby officials from the scheme will visit the area and randomly ask members of the public for their views. An event is also planned for 13 November for the Clerk and the Lengthsman to attend and give a presentation of the work carried out to date. The continuation of the scheme and the financial implications will be considered in the next budget for 2013.

d) Play Area Funding

Cllr. K. Watkinson reported that the Bridge Company at Dunham on Trent had donated £1,000 and the current total is £3,340. A substantial grant of £26,000 has been submitted to Wren. Confirmation of the Parish Council signaturies for the account (should this be successful) are noted as the Chairman, Maurice Mathews, Vice Chairperson, Lynne Sharpe and Parish Councillor Madeline Barden.

e) Village Signs

The new signs were viewed and are now being manufactured.

f) Proposed Steam Railway

A reply was received to an enquiry regarding the above was received from Bassetlaw District Council – the District Planning Authority is not aware of any proposals for this to be operated on a disused railway line. It is quite likely to be the case that this project would not require planning permission.
