

CHARLTON PARISH COUNCIL MINUTES OF THE MEETING HELD ON TUESDAY 19th March. 2024 at Charlton Church Foxcotte Room at 7.45pm

Present: Cllr Ward, Cllr Smale, Cllr N Woods, Cllr D Rawlingson, Cllr P Wylde, Cllr Wilson In attendance: E Attwood – Clerk 4 members of public

 Election of Chairman – The Clerk explained that Cllr Smith had resigned therefore, the first item on the agenda was the election of a chairman. Cllr Ward agreed to become Chairman. Proposed by Cllr Wilson Seconded by Cllr Smale. All members agreed. Resolved: Cllr Ward was elected Chairman. Chairmans Remarks. Cllr Ward expressed his thanks (on behalf of the council) to Cllr Smith for her excellent service during her time as Chairman and Councillor.

2. Apologies for Absence – Cllr Lashbrook & Cllr Donnelly

3. Declarations of Interest

There were no declarations of interest in items on the agenda.

4.Minutes - Resolved: The minutes of the Parish Council meeting held on 20th February 2024 were confirmed as a correct record and signed by the Chairman. Proposed Cllr Rawlinson seconded Cllr Wilson. All members agreed.

5. Public participation – The following concerns were expressed by members of the public Land at Goch Way:

- Could not find any real changes in the Planning application.
- Not sure who the trees belong too as the boundary is disputed.
- Water/springs flow from field above (which is where the proposed build will take place) into lake. Surface water is a huge concern.
- Distance from lake to proposed new build has not changed.
- No information in plans about main sewage and the need for a pumping station.
- Who looks after pumping station if there is a problem.
- Pumping station would need to be on the boundary line.
- Water from Peake Way is currently backing up and causing problems. Water flows into soakaway at Charlies Lake.

6. Clerk's Report

- Cllr Smith resigned as Chairman. The Clerk will inform TVBC.
- Cllr Rawlingson booked onto HALC Audit Course.
- Invoices sent out for advertisements in the newsletter.
- Insurance claim has been paid out £667 for burnt out bench less the excess.
- TVBC responded that they could not place cameras in Charlton Waterside as it is too intrusive to residents at Carters Meadow.
- Potholes filled at the bottom of Carters Meadow by Hampshire Highways.
- Replacement Millenium tree has been planted.
- TVBC do not want to remove bench so arrangements will need to be made by PC.
- Report about potholes Foxcotte road not actioned by Highways yet advised Parishioner to upload photos and send a copy to Clerk. Hantsweb report says they have been inspected and are part of scheduled works.
- TVBC have offered site visit and quote for cutting back footpath to Enham for the Autumn work.
- Automatic response to saplings request, no further news

7. Cllr Donnelly sent the following in a report:

- HCC Budget 24/25 will rise by 4.99%.
- Has been informed that Foxcotte Lane and Upper Drove resurfacing will be scheduled for 24/25 by Hampshire Highways but no date has been given.
- Rainfall last month locally was double the average 161.7mm in comparison to a February average of 81.1mm

Cllr Wilson was disappointed that the white lining work was not effective in reducing the amount of traffic exceeding the speed limit on Hatherden Road and therefore funding should have come from Highways, not the Parish Council, as they recommended the improvements. Cllr Ward explained that this had been agreed in previous meetings as Highways were not willing to add these additional traffic calming measures.

Local Plan Consultation responses due by 12 noon – Cllrs Smale outlined the Local Plan. It was suggested that it should be made clear that Charlton should be treated as a village and not as an additional part of Andover. It is necessary for Charlton to be identified separately including the inset maps and it will be requested that this is corrected on the next revision. It was agreed that affordable housing should be a top priority and the Parish Council would not want the policy to be eroded by several smaller developments.
