District Council (SODC)	SODC Councillor Phil Cross noted the following :- <ul style="list-style-type: none"> • Ongoing support for the Community Building Project by supporting its application to the Big Society fund; • Awaiting a final response from Central Government regarding the SODC Core Strategy; • The SODC Council tax element for 2012/13 is being reduced by 2.5%. Thames Valley Police, the County Council and SPC are all proposing a nil increase; • Consultation continues regarding SODC councillor numbers with a proposal for a 25% reduction (36 from the current 48). SODC Planning have advised that the development is being monitored closely and that there have been no breaches of planning permission as determined by the Planning Inspector as yet. An application for licensing has yet to be determined. It was reported that the residential caravan located on the track to Gotham Farm (agricultural ground owned by Mr. Nixey) has been removed but that it has left a lot of rubbish. Cllrs LE and BG reported regarding the informative 'Roles and Responsibilities of Councillors' training that they attended at Didcot on 27/2/12. The agreement will shortly be ready for signing.</p> <p><u>Forge Garage Development</u> Horseshoes - The Darby's litigation department is in the process of composing a letter to be sent to Mr. & Mrs. Heather (Forge Garage) regarding the need to agree a Deed of Easement with SPC for access to the parking space at the side of the house.</p> <p>Anvils - The railing type fence at Anvils has also been moved towards the road recently to accommodate a much larger vehicle. Pedestrians now have to walk on the road to get round the moved railings and this is creating a significant risk to children and to parents with buggies at what is already a dangerous corner. This means that the new Saturday evening and Sunday 101 services will run for at least the next 12 months.
