

SAFEGUARDING POLICY & GUIDANCE

Adopted November 2019. Updated June 2021 For review July 2021

1. Policy Statement

Everyone has a duty to safeguard children, young people and vulnerable adults.

Mapledurwell & Up Nately Parish Council will undertake all reasonable measures to promote the safety of children, young people and vulnerable adults who are using Parish Council Premises and Facilities.

<u>Promoting a safe environment</u> The Parish Council has powers to provide and equip buildings for sports, social or educational use and to provide recreation grounds, open spaces and a wide range of recreational facilities. The Parish Council is committed to ensuring in so far as reasonably practical that all necessary safety procedures, risk assessments, maintenance schedules and equipment checks are in place and acted upon to ensure the wellbeing and safety of all users and visitors.

This Policy applies to Mapledurwell & Up Nately councillors, employees, contractors and hirers.

<u>However</u> Mapledurwell & Up Nately Parish Council has no direct powers or responsibilities for Community or Children's groups or services. The primary responsibility for the welfare of children or vulnerable adults rests with the responsible adult – parent / carer / sports club / coach / team leader.

When using Parish Council facilities or attending events organised by the Parish Council, children, young people or vulnerable adults do so with the consent of a parent, carer, or other responsible adult.

2. Definitions

- 2.1 Children and young people
- Anyone under the age of 18 years.

2.2 Vulnerable adult

- Anyone over 18 who is:
 - Unable to care for themselves
 - Unable to protect themselves from significant harm or exploitation, or may be in need of community care services.

2.3 Child abuse

Somebody may abuse or neglect a child by inflicting harm,
or by failing to act to prevent harm.

3. Parish Council Facilities

3.1 Children's playground

Provision for younger children supervised by parent / carer /responsible adult. Provision and maintenance. Equipment replaced (other than swings) in 2015. Updated 2016/17, additions 2017/18. Maintenance by Hampshire Community Payback Team in 2017/18. Equipment cleaned and pickett fence repaired by contractor 2019/20 (non toxic wood treatment used).

Monthly inspections by RoSPA-certified Parish Councillor. Plus formal annual RoSPA inspection.

Additional considerations – Community Payback team – selected minor offenders supervised by team leader (Interserve Justice Community Rehabilitation).

3.2 <u>Tennis courts</u> – Used by Parishioners of Mapledurwell & Up Nately only, who register to receive the padlock combination code for access. Used by children under supervision, responsibility of parents, carers.

3.3 Pavilion

Refurbishment 2018/19

- Used by Chineham youth football team (Chineham Tigers) with supervision of appropriate adults team coach, club members.
- 3.4 Recreation Ground used as above.

Also for public use (mostly dog walkers), any children present are the responsibility of their parents / carers.

3.5 <u>Village Hall</u> – Held in trust by – and responsibility of – Village Hall Committee.

Nursery School held in the hall uses Parish Council-owned outdoor space.

It has been minuted that the Monkey House Nursery School wishes to be responsible for its own portable outdoor fencing system to keep the children safe and secure while outdoors under supervision of the Nursery staff.

- For private functions hire, any children, vulnerable people present are the responsibility of their parents / carers.
- 3.6 <u>Allotments</u> Any children, vulnerable people on site are the responsibility of parents, carers. Allotments to be used as per the contract agreement.

4. Informing the Appropriate Authorities

While safeguarding is a general responsibility, it is not a general responsibility to determine if any abuse is taking place. Any concerns should be reported to the appropriate authorities.

Children's Services is dealt with by Hampshire County Council.
