#### 019/010 PLANNING

 (i) 20190735, The Old Chapel, The Street, Oulton The Council agreed to SUPPORT this application with the following comments:

Southern elevation at rear would be better with a brick facade to fit in better with existing.

IF the roof needs replacing and if PV panels are to be installed the council hopes these will require a further application.

Council is also concerned that once again two applications were submitted but the Parish Council was only informed of one. It was by pure chance that the second application (20190701) was picked up by one of the councillors. Council is concerned that they are not being kept fully informed of applications and would like an assurance that they will be in future.

## (ii) WINDFARMS

Orsted. OPC have attended the whole of the examination process [a] with attendances at hearings and written responses which are available to see on the parish council's website. The examination for Hornsea Three has now closed; The Examination authority has three months to make their recommendations, it will then go to the Secretary of state who will also have three months to make a decision as to whether the Development consent Order is granted. The final outcome will be announced in October 2019. Vattenfall. Alison Shaw & Susan Mather attended the issue specific [b] hearing in Norwich on 24th April, OPC along with BDC raised issues relating to the noise assessment and air quality and as a result the applicants have been asked by the ExA. To produce some updated information this they have now done and OPC is reviewing the documents before responding at deadline 8.In the evening of 24th April OPC attended the Open Floor hearing in Dereham, this is the public's opportunity to put forward their views, and the event was very well attended. Alison Shaw spoke on behalf of OPC and Susan Mather spoke on behalf on Professor Tony Barnett (Corpusty & Saxthorpe PC) who was unable to attend and whose views are endorsed by OPC.All of OPC's responses for Vattenfall are also available to view on the website.

[c] It was **AGREED** to send a reply to a proposal for a Statement of Common Ground, as follows:

Statement of Common Ground, Oulton Parish Council can only agree on the following statement.

It is agreed by both parties that the strategy to install ducts for both projects and the decision to commit to HVDC will reduce impacts to residents.

Regrettably there has been an increase in concerns over recent weeks, which have not reassured OPC and, as with Orsted Hornsea Three, we cannot see how the cumulative traffic from both projects will not be hugely impactful on the residents of The Old Railway Gatehouse and the wider community for a protracted period.

Although Vattenfall have been forthcoming in answering our inquiries, and OPC very much appreciates the time spent and good humour afforded us during these discussions; nevertheless the unique complication of two very similar projects potentially crossing Norfolk at the same time, and both impacting Oulton village and surrounding area has been challenging and will remain so as there are areas of outstanding issues which OPC cannot foresee being resolved.

## 019/010 PLANNING (continued)

OPC will be submitting a response at deadline 8 which will form comments regarding the most recent Noise and Vibration assessment, Air quality assessment and observations regarding the decision not to use trenchless crossing on B1149.

• The trenching of the B1149 and road widening to create a single lane access, which will complicate the traffic flow of existing and HOW3 AIL to the Main Compound

• Noise assessment mitigation for 'The Old Railway Gatehouse' will only resolve Vibration but engine noise will still be audible on the approach, stopping and on leaving the regraded section of road.

Air Quality: OPC still fail to understand how existing and cumulative traffic NO2/Particulate matter will not be impactful over several years to the 'The Old Railway Gatehouse' and the wider community along shared access routes. Oulton Parish Council have determined that signing any form of SOCG does not add anything meaningful to the planning process, and could, in future be misinterpreted as it having reached an acceptance of the project, should it proceed.

[d] George Freeman MP has invited representatives of the Council to join him in meeting with Claire Perry MP, Minister of State at the Department for Business, Energy and Industrial Strategy to discuss an Offshore Ring Main project. It was **AGREED** that the Chair and Ms Shaw should attend. It was **AGREED** that travel expenses would be paid.
