This is the Initial Assessment of the Principal Issues prepared under s88(1) of the Planning Act 2008 (PA2008). This initial assessment has had regard to consideration by the Examining Authority (ExA) of the application documents and of Relevant Representations received in respect of the application.

It is not a comprehensive or exclusive list of all relevant matters. The ExA will have regard to all important and relevant matters during the Examination and when it writes its Recommendation Report to the Secretary of State for Business, Energy and Industrial Strategy after the Examination has concluded.

The order of the issues listed is alphabetic and does not imply any order of prioritisation or importance.

The policy and consenting requirements and documents associated with the PA2008 are an integral part of the Examination and are therefore not set out as separate Principal Issues.

The ExA has accepted the Applicant's response to s51 Advice issued by the Planning Inspectorate at acceptance of the application. This can be found in the Examination Library under the section 'Additional Submissions'.

It can also usefully state where and why there may be disagreement about the interpretation and relevance of the information. The reasons for the differences and interpretation of the implications of a difference can then be expanded in the evidence. Unless otherwise stated or agreed, the SoCG should be agreed between the Applicant and the other relevant Interested Party or parties, and submitted by the Applicant.

In view of the relationship between this application for Development Consent and the Norfolk Vanguard Offshore Wind Farm application for Development Consent made by the same Applicant, the ExA would be assisted by the preparation of an updated draft Development Consent Order including Protective Provisions and Deemed Marine Licences and an updated Explanatory Memorandum.

This should be informed by and take account of the draft Development Consent Order submitted by the Applicant at Deadline 9 of the Norfolk Vanguard Examination. This should be submitted by **4 November 2019**.

6. Site Inspections

The Panel has undertaken a number of Unaccompanied Site Inspections (USIs); and intends to continue unaccompanied inspections of other publicly accessible locations at the substations site, along the proposed cable route and at the landfall zone.
