Last year we absorbed the majority of the management of this waste and the cost associated to it ourselves. Following conversations with the Wraxalls (beach owners) they agreed to supply an additional bin to help with this increase. The bin shown here is this bin. I will speak with Nigel regarding the frequency of collections in the hope they can be more frequent. I'm sure he will be happy to help. In the meantime I will arrange for anything outside of this bin to be removed to prevent it ending up on the beach/in the sea. Should you have any concerns regarding the pubs waste management please pop your head in the pub and I will be happy to help. We feel especially privileged getting to live and work in such a beautiful location and feel a responsibility to help keep it that way."

As this area is owned by the Palmers brewery, we would like to request that Palmers install signage on this approach to allow enforcement of the PSPO to take place and consult on the best way to do this in a way that is beneficial to both residents and visitors of the beach as well as ensuring that it is done in such a way that preserves the attractiveness of the site. 26	30/06/2023	Traffic incident on A35	Website contact	In	Chideock resident	"I am writing to express my concern that Peter Hunt wishes the Parish Council to send a report to the Highways Authority regarding an accident to the which occurred during the afternoon of the 26th of June 2023 on Main Street close to the Village Hall just to highlight the ongoing safety problems on the A35. At the point of impact, the carriageway is clearly wide enough for two buses to pass so there was ample room for the vehicles involved to pass. The Police are more than capable of interpreting the skid marks to ascertain what or who if anyone was at fault and will proceed in accordance with their findings. The assumption that the female driver panicked and turned the steer wheel to the right into oncoming traffic causing an accident and not to the left is I believe both demeaning and insulting to the driver. Unless the driver has agreed in writing or there is independent third-party evidence to support this assumption the Parish Council should involve itself. Should this assumption fall into the wrong hands i.e., the driver's insurance company would bring in to question the ability of driver being on the highway, the Police or the Courts are the only persons allowed to question the driver's ability."
