#### Finance

The Precept levied for the financial year 2019/2020 was £16,980.00.

Other income during the year was Bank interest of £108.72, plus VAT refund of £265.32, a cashbank payment of £60.00 and a grant for the village hall of £2,400.00.

The total income for the year was £19,814.04, which when added to the accumulated balance gave a working total of £53,705.55

During the year total expenditure was £11,614.43 which results in a surplus of £42,091.12 Included in this are £17,441.11 of earmarked funds.

## **Planning**

All planning applications received from Warwick District Council, and a number from Warwickshire County Council are considered.

During the year a total of 30 new planning applications were considered, with 8 outstanding from the previous year.
