#### 1 APOLOGIES

Apologies for absence were received from Cllr John Brooker, due to work commitments and from Cllr Mrs Sheila Goodworth, family bereavement, which were accepted. ### 2 DECLARATIONS OF INTEREST

159 Cllr Mrs Howie declared a personal interest in item 5a(i), planning application for Winterdale Shaw, as she lived close to the site.

### 3 MINUTES OF THE MEETING HELD ON 1 JULY 2013

It was proposed by Cllr Goring, seconded by Cllr Miss Howie and agreed the minutes of the meeting held on 1 July 2013 be signed as a true record.

### 4 MATTERS ARISING

No matters were raised.

### COUNTY AND BOROUGH COUNCILLORS' REPORTS

The Chairman suspended the meeting for the County and Borough Councillors to give their reports.

Cllr Mrs Hohler said that a new head had been appointed for the school but had subsequently withdrawn. An experienced Headteacher who had taken early retirement had been appointed. He wanted to work with the community. A meeting had been held with the owner of Cob Trees and the posts would be moved back. A policy of switching off street lights between midnight and 5 am was out for consultation and a pilot scheme would be introduced. She was concerned about cyclists who were using Stansted Hill for time trials. A resident of Labour-in-Vain Road had applied for 12 month occupation of his log cabins.

The Chairman thanked Cllrs Mrs Hohler and Mrs Kemp and reconvened the meeting.

As PCSO Bullen was present, it was agreed to vary the order of the agenda.

#### 170 i Field Shelter, Plaxdale Green Road

The photographs taken by Cllr Bott had been forwarded to enforcement.

#### 171 ii The Old Rectory, Stansted - Front Garden

It was reported a planning application is required.

#### 172 iii Cob Trees, Hatham Green Lane

As reported by Cllr Mrs Hohler, the bollards would be removed.

#### 173 iv Oaktree Farm

The matter of probable completion of building works and therefore removal of the caravan had been reported to the planning case officer and enforcement.

#### 174 **Thriftwood** V

Enforcement had informed the Clerk that unannounced visits had been made with nothing untoward and that the site would continue to be monitored.

#### 175 vi Land adjacent to Whytecroft, Vigo Road, Stansted

Cllr Bott reported that the land had been sold with planning permission for stables. Shortly after the sale, a large wedding had been held on the land. He had informed the Local Planning Authority. There was a need to ensure that all breaches were reported quickly. Anyone could do this at any time - out of hours calls to the Borough Council were forwarded to an emergency number. It was understood from Cllr Mrs Kemp that calls were responded to and unlawful occupations of land were dealt with immediately. Reassurances on this point had been received from the Borough Solicitor and from the Head of Planning.

#### 176 vii Cabins, Labour-in-Vain

Cllr Bott referred to the cabins mentioned in Cllr Mrs Kemp's report. The site was in Wrotham parish, but affected residents of Stansted. Only 3 people had been notified and the Council had not been consulted as a neighbouring parish. He wished to make Stansted residents aware that there were 33 plots, of which 2 were occupied full-time. If all were occupied for 12 months, there would be an additional 1,100 traffic movements each month. It was understood from Cllr Betts of Wrotham Parish Council that his council was doing its best with the situation but was struggling. He had made Cllr Martin Coffin aware.

#### **Wrotham Hill Boot Fair** 177 viii

Cllr Bott said that a number of people were concerned about the boot fair. Since it had changed hands, litter was being left, the Portaloos had not been removed from the site and cars were being parked along the A20, rather than being contained on the site. He had spoken to the owner of the field. The Clerk was requested to write to Wrotham Parish Council in time for their next meeting with a copy to the Borough Council.

### 178 ix Oakwood, Fairseat

Cllr Mrs Falconer said that it appeared the garages were on the boundary of Oakwood Farm Cottage. The Clerk was asked to investigate and let Cllr Mrs Falconer have a copy of the plans.
