Minutes of Mersham with Sevington Parish Council Meeting held in on Monday, 23rd September 2019

To be actioned by **Apologies for Absence** Apologies had been received from Cllrs Oakley-Hills and Townsend. Declaration of interest in items on the agenda There were no declarations of interest made. **Discussion regarding the Aldington Frith Site** Mr Mickelborough and Mr Coulson introduced themselves to the meeting and explained that they are looking at the viability of the site and looking for an opportunity to extend the permitted residential development, currently the permission covers 10 houses as conversions to the current buildings. The developer and owner are looking to achieve more from the site and want to replace the buildings rather than convert them. The site now has potential for expanding its value and the gentlemen wish to work with the Parish Council to understand local thoughts. What would the need for housing/design/layout be? Once designed a change to the application will be submitted. Cllr Murphy suggested that Quarry View could be used as a suggestion for size and type of houses. Cllr Turley explained that local people didn't want the change of use but the new proposal could be less detrimental to nearby residents. Mr Mickelborough stated that he is looking at betterment through HOU5 and believes it is likely to be passed as it is a brownfield site and has been adopting a worst case scenario by undertaking this strategy. Mr Mickelborough stated that he was presenting an opportunity for the Parish Council to have an opinion as he believes that this can be realised under HOU5. Cllr Turley suggested that HOU5 would not be applicable as this is an isolated site. Cllr Bartlett explained that he would expect such a decision to be made by committee. Cllr Turley suggested that there could be an offer of separate benefit to the parish. It was agreed that this would be discussed at the October meeting and the meeting would be relocated to be in Mersham and not Sevington as was previously planned. Mr Mickelborough and Mr Coulson were thanked for attending. Minutes of the Meeting on 15th July 2019 were approved as a true record and signed accordingly. **Matters Arising from the Minutes** Solar Panel costs were circulated and it was agreed that the panel should be purchased. GM Public session: To receive questions and comments from the public on any agenda item. The members of the public had no comment at this time. **Report from Borough Councillor** J10A Contractors advise that we have seen the last full closures of the M20 as part of the J10A works. Future work can be accommodated with single lane closures. The plan is for the junction to be open in good time for 31 October 2019 so that Kent is "Brexit Ready". This is to allow improved access for lorries to the lorry

park. HMRC wish to use at least 600 of the spaces as a Customs Clearance Depot once the UK is no longer

requested a traffic impact assessment so they can understand how Orbital and Barrey Road/Church Road will be affected. The plan at the moment is the Operation Brock on the M20 between J8 and J9 will be

part of the single market and the new junction will provide lorry access for that as well. KCC have

reinstated in both directions from 21st October. *Amended now to October 19th*.

Cllr Bartlett considers it likely that the Orbital roundabout would be at a standstill and that the installation of the traffic lights allowing departure from Finberry in both directions is likely to be delayed by a further 18 months.

ROAD IMPROVEMENTS

The latest schedule of road improvements has been published by KCC and there are two projects in the Parish. First, a survey of the Flood Street bridge over the East Stour for strengthening and reconstruction is being carried out with the concrete blocks. Second, various sections of the A20 between Bockham Lane to the Folkestone & Hythe District Boundary will be repaired and treated to extend its life before renewing / reconstructing.

FINBERRY VILLAGE CENTRE

A planning application has been submitted by the Church Commissioners for the Village Centre next to the School. Full details are at https://planning.ashford.gov.uk/Planning/details.aspx?systemkey=113377

The application is for Land south-west of junction of, Bullfinch Avenue, Finberry, Sevington, Ashford a mixed-use local centre scheme 63 comprising residential dwellings, up to four retail units (comprising a convenience foodstore and up to three other units) and a public house, all with associated parking. Consultation runs up to 29th September. This is the opportunity for residents to say what they want for the Village Centre.

FINBERRY BUS SERVICE

The following map shows the location of the bus stops that were required of Crest on Finberry as part of its planning consent. Crest is also required to pay a financial contribution towards the bus service to KCC.

Crest has said their funding will only be released to KCC once Stagecoach confirms they will extend the B route from Bridgefield to Finberry. However, Stagecoach will only extend the B line to Finberry once KCC confirm that funding issues for the Bridgefield service are resolved. KCC require assurance over evening services as there are strict service level conditions that must be met by KCC before money is released. Discussions are ongoing.

KENT PLAN BEE

Kent's Plan Bee is an action plan that sets out how the County Council can make a greater contribution to slowing and reversing the decline of pollinators in Kent. The Plan responds to the National Pollinator Strategy for England's work that will benefit pollinators. KCC with its responsibilities, services and land holdings can make a significant contribution directly through land management and leadership to safeguard our native pollinators. Pollinators are in serious decline and many plants rely on insects to pollinate their flowers — most plants cannot set seed without being pollinated.

Actions will include

- Revising grass-cutting and pollinating-friendly planting regimes
- Review how it reinstates land and manage it on road verges, in maintained schools and parks and all other parts of its estate.
- Review the use of pesticides and seeking to end the controversial use of neonicotinoids.
- Green its buildings with assets with pollinator friendly planting, and
- Protect pollinator habitats.

KINGSNORTH GREEN

The South of Ashford Garden Community, which includes the Chilmington, Court Lodge and Kingsnorth Green developments, have been named as one of 19 garden villages announced by the government which will receive a share of a £3m fund to help with the next stage of their development. The scheme has been allocated £150,000 funding to support their delivery.

Construction at Chilmington is underway while sites at Court Lodge and Kingsnorth Green are allocated for development in the Local Plan to 2030, and planning applications for these sites are due to be considered by the planning committee in the coming months.

The creation of well-planned and designed, locally-led garden communities makes a critical contribution to the government's ambitions both to build 300,000 homes a year by the mid-2020s, and to provide a stable pipeline of homes for the future.
