## Villager of the Year

The Chairman noted that he met with the recipient, who unfortunately couldn't attend the meeting, and it was agreed that she will be formally given the award at the October meeting.

#### **Open Forum**

Mr.Legg brought up the matter of the non emptying of the rubbish bin on the playing field and noted that it has been eventually emptied after 10 weeks or so. The Clerk noted that Mr.C.Dobson of the District Council was in liaison with Biffa to determine how it has been missed and to put into place procedures whereby it will be emptied on a regular basis. Mr Legg also noted that the grass is long and in clumps on the playing field, and after discussion during which dissatisfaction with the current mowing contractor was voiced, the Council agreed that there should be further mowing and reseeding of the field to bring it up to an acceptable standard.

The Chairman brought to the attention of the Parish Council an email from Cllr.Bennett in which she indicated that on medical grounds she was tendering her resignation. After discussion it was proposed by Cllr.Banham, and seconded by Cllr.Warner that the resignation be accepted. The Clerk is to write to Cllr.Bennett thanking her for all her valuable work over the years, and to purchase some flowers as a tribute.

This concluded the Open Forum, and the Parish Council meeting began formally.

# Matters arising from the minutes of the 20th July 2015 meeting

Scout Field: The Chairman noted that M&T Sharples asked for a meeting with the Scouts and Parish Council to discuss the field and that this has been agreed for later in the week.

Barley Mow site: Cllr.Banham noted that bin area would appear to be directly outside his neighbours house, and also that any visitors to the future occupants of the site may have to park in Post Office lane

to the detriment of the occupants of the lane. It was noted that there are currently two extra parking places on site for visitors. The Clerk is to write to the developer granting an easement over the green for access to sewers, and also asking that the Parish Council meet with the developer to discuss access for the flats opening directly onto the green, and the possibility of returning the concrete hardstanding back to village green.

15/02710/FUL, 22 Earles Close: Single storey rear extension to include replacement of the conservatory to form a porch – No representation
