6/1920 PUBLIC PARTICIPATION SESSION

A member of the public spoke re 19/01822/VAR - Land Opposite The Crescent, Nesscliffe, variation of condition No2 (plans) attached to application ref 18/04941/FUL dated 26/10/2018 to allow for an additional adoptable road on site. Concern was expressed that this could be used to access land to the rear for future development. It was noted that the reason for the change is because access is otherwise via Phase 1 which is raising concern with solicitors for house buyers.

Road repairs were raised, with Valeswood Lane being highlighted as a problem area as there are potholes where the new water main went in and the road surface is breaking up. It was noted that the expansion gap between Pentre and Great Ness on the bridge over the A5 is now a big bump.

It was reported that when the perimeter fence at the army camp was replaced part of footpath was dug up and not yet replaced and the defibrillator is now the other side of the camp fence.

Footpath opposite The Crescent	Ongoing	Developer has replied - you will remember that this was brought up last year when you had received a similar complaint. The matter was discussed with Shropshire Council who confirmed that the arrangement at present was adequate until the footpath adjacent to the 2nd phase was complete. As you can see from the work on site we should be able to complete the footpath soon and as part of those works the dropped kerb will be installed.
Soil on old A5 opposite Phase 2 development	May 2019	The developer has replied and said that there has indeed been a small amount of soil dropped, which has now been removed. There is also a blocked drain, however the drain is above where the soil was dropped and definitely not blocked recently. We will investigate further as it was not draining away the storm water during the rainstorms yesterday.
Bridleway	May 2019	Shrewsbury Homes have advised that a bridle way sign has been placed on the field verge of the phase 3 land up toward the school. You can see that the sign is from another location as the rear of the post has recently been broken. I attach two photographs, perhaps this could be investigated because as far as I can deduce there is no Bridleway across the field. Clerk to reply.
