- 4.5 Annual Governance Statement The Committee completed the Annual Governance Statement answering Yes to the assurances relating to the preparation of the Statement of Accounts and the Committees internal controls.
- 4.6. Accounts 2022/23 The accounts for the year ended 2022/23 were NOTED and Cllr Mrs Oxtoby PROPOSED that the dates selected for the period of exercise of public rights are confirmed from 05 June 2023 to 14 July 2023. SECONDED: Cllr L Glander and AGREED.

#### 5. Land and Site Maintenance

- 5.1 Maintenance it was NOTED that the strip of land separating New House Shaw and Barnetts Wood has been cut back. The dead Ash trees in the north west corner will be felled with no increase to the quote received in September 2022.
- 5.2 Hedge Cutting Cllr Mrs Oxtoby PROPOSED that the request from New Ash Green Horticultural Society not to reduce the height of the hedges on the boundaries between the allotments and Northfield is AGREED, but that these hedges will continue to be faced when necessary to comply with the requirements of the Rural Payments Agency Basic Payments Scheme.
- 5.3 Fly-tipping it was NOTED that Sevenoaks District Council have quoted £350.00 plus VAT to clear the camp in Barnetts Wood.
- 5.4 Woodlands Plan a request will be sent to two tree surgeons to obtain their opinion to coppice the ancient woodland and to provide a quote and programme of works in relation to the remainder of the Woodlands Plan.
- 5.5 It was NOTED that Cllrs Mrs Oxtoby and L Glander and Mrs de Jager met with KCC staff on 29 March 2023 with a view to planning another small woodland. Within the grant from KCC, they will supply and plant the trees with a maximum area of 0.5 acre. A response from KCC is awaited.
- 5.6 Quantified Tree Risk Assessment it was NOTED that the dates for the inspection were set for 26 April and 10 May 2023.
- 5.7 Hay cutting it was NOTED that the field has been harrowed by the contractor.
- 5.8 Rural Payments Agency it was NOTED that the 2023 Basic Payment application has been submitted.
- 5.9 Interpretative Panels no progress to report.
- 5.10 Matters raised by members none.
