**TEMPORARY PROHIBITION OF DRIVING**

Road Traffic Regulation Act 1984 – Section 14 (2)

**Kent County Council gives notice that A28 Canterbury Road, St Nicholas at Wade, Birchington will be closed to through traffic, on 5<sup>th</sup> August 2019 for up to 5 nights.**

**The road will be closed Birchington bound only, between the St Nicholas Roundabout and Little Brookfield Farm.**

**The alternative route is via A299 Thanet Way, A299 Canterbury Road West, A299 Hengist Way, A256 Haine Road, A254 Margate Road, A254 Ramsgate Road, College Road, Hartsdown Road, George V Avenue and A28 Canterbury Road.**

**It is planned that the road will be closed between 19:00 and 05:00.**

**The closure is necessary to enable Kent County Council to carry out carriageway repairs under the Find and Fix scheme.**

**This Notice applies when the relevant signs and barriers are on site and is valid for a period of no more than 5 days.**

**TEMPORARY 30 MPH SPEED LIMIT**

Road Traffic Regulation Act 1984 – Section 14 (2)

**Kent County Council gives notice that, for the safety of the public and workforce during roadworks, a temporary mandatory speed limit of 30-mph will be imposed on a section of A28 Canterbury Road, St Nicholas at Wade, Birchington.**

**The 30-mph speed limit applies for Birchington bound traffic on A28 Canterbury Road, St Nicholas at Wade, Birchington, between the junctions with St Nicholas Roundabout and the Brooksend Service Station, to the extent indicated by signage clearly displayed on site.**

**This takes effect on Monday 5<sup>th</sup> August 2019 for up to four days, whilst the road is open to traffic. The restrictions will be lifted as soon as works are completed and is safe to do so.**

**The restrictions have been introduced for the safety of the public and workforce whilst the road is being resurfaced.**

**This Notice applies when the relevant speed limit signs are placed on site and is valid for a period of up to 5 days.**
