Erection of first floor rear extension

Cllrs recommended refusal as Cllrs were concerned of the impact of the amenity on No.1 Howland Cottages, Howland Road from the 1st floor extension and was contrary to Marden Neighbourhood Plan Policy BE2.

RESOLVED: Refuse contrary to MNP Policy BE2.

Demolition of adjacent barn. Erection of a two-storey side extension with basement

Cllrs raised no objection to this application

Change of use from agricultural to commercial storage (use Class B8) (retrospective)

Cllrs raised no objection to this application.

Submission of details to discharge condition 2 – decentralised and renewable or low-carbon sources of energy; condition 3 – method statement; condition 4 – slab levels; condition 5 – written details and sample of materials; condition 6 – hard and soft landscape scheme; and condition 11 – sewage disposal. Subject to 20/505101/FULL

Cllrs noted all conditions but raised concern over Condition 11 – The plan does not fully identify the sewage disposal. It does not demonstrate where the sewage flows to and where the Klargest system is located.

RESOLVED: Cllrs wished the Clerk to respond to this submission of details with concerns over Condition 11 of 20/505101/FULL.
