Hedgerow varieties: Blackthorn, Hawthorn, Dogwood, Dog Rose & Goat Willow.



#### WILDFLOWER PLANTING - NEWNHAM GREEN



Deborah Whitfield, Consultancy Manager for Hampshire and Isle of Wight Wildlife Trust, has advised on management and planting for sections of the Green, the verges and pond margins. Grant funding will be needed so hopefully looking to spring planting with a selection of the species suggested.

Newnham Village Green SINC site visit of 15th September and subsequent management advice:

#### **GRASSLAND AREAS**

The area next to the pond is to be managed as a grass and wildflower meadow. It is recommended that this is cut twice a year, early spring (April) and late summer (end of September) to allow the flowers to set seed, but no shorter than 5cm. A mown path cuts across the area and it is recommended that this is kept to allow access, add visual appeal and minimize disturbance to wildlife.

The majority of the grassland sections have amenity use and are cut more frequently, but it is recommended that 'buffer strips' be left along a selection of the edges adjacent to the drainage ditch banks. This will create a gradation of habitats known as an 'ecotone'. The buffers could also be cut twice a yea to prevent obscuring vehicle site lines (early spring April and late summer end of September).

Arisings should be removed and composted off site if possible, alternatively piling in a chosen area would be ok and also create additional habitat for reptiles.

#### DRAINAGE BANKS

The drainage banks could be enhanced with wildflower planting. A trial section of seed mix has already been sown but these have mostly been being outcompeted by existing more dominant species.

Sowing seed is the most cost-effective way to create a wildflower area but due to the presence and composition of the existing sward, which contains dominant grasses and herbaceous plants, some preparation of the soil would be needed to enable the wild flower mix to establish. This would mean removing the existing plants to expose the soil.

Therefore, if funding could be sought, introducing some plug plants of broadleaved perennial wildlife flower species may be more effective and

would avoid removal of the existing biomass. If planted at a high density they would have more chance at establishment eg cowslips would be good plant to try and establish this way. The drainage banks could be cut twice a year to prevent obscuring vehicle sight lines (early spring April and late summer end of Sept). Suitable perennial species for a clay cap over chalk include:


#### *'PARKLAND'* AREAS

The areas of the Green with grassland and mature trees could be enhanced with some native spring bulb planting for example bluebell and wild daffodil. These will thrive best in glades and edges with available light.




be reduced in November to prevent scrub build up and encroachment that would lead to drying up of the pond.

Planting up of the pond with some more native species could also enhance the diversity of the pond, for example introducing marsh marigold, purple loosestrife and more yellow flag iris would be beneficial to insects and aquatic invertebrates, as well as provide more structure to attract damselflies and dragonflies.

#### THE LODDON VALLEY

The rivers Loddon and Lyde are chalk streams internationally rare, valuable and fragile habitats, home to a diversity of wildlife and priority species.

The Valley environments are the heart of wildlife corridors between the river ecosystems, fields and hedgerows, and pockets of ancient woodland.

The Inspector for the currently Adopted Local Plan in his final Report (2016) commented on avoiding 'unacceptable environmental impacts, for example on the quality of the landscape and Chalk Rivers' (para 64) and that... (para 128) 'the Loddon Valley forms an effective barrier to further significant growth of the town to the east...'

Specifically... (para 191) re Lodge Farm and Poors Farm... 'the EA has objected on the grounds of flood risk and impact on the River Loddon and associated wetlands on biodiversity grounds.' (Para 192) 'The site at Hodds Farm also has sensitive landscape and biodiversity issues. ...whether impact on the biodiversity of the Loddon Valley can be mitigated to an acceptable standard... it is difficult to see at this point in time how this could be achieved'.

#### PARISH COUNCIL COMMENTS WILL INCLUDE

- Climate emergency should be central to Planning Policy.
- 'Put the Environment at the centre of policy making' as per the pledge of the Environment Bill.
- Provision for Wildlife should be afforded much higher status. The topic heading '3. Environment and Heritage', should include 'Wildlife habitat, networks & ecosystems' - or better that Wildlife etc has its own separate heading.
- At 3.1 Chalk Streams should be included within 'Environmental Assets'.
- At 3.5 Developer Contributions should also be explicitly required for wildlife habitats & networks. Policy should be specific and proactive for accommodating and integrating nature and wildlife beyond mitigation and 'net gain'. Detailed data and monitoring is needed. **Ecologists should work alongside Planners.**
- To fully support the Wildlife Trust's call for 'Re-wilding the Planning System'. Wildlife habitats, wildlife corridors need to be integral to all planning policy - everywhere alongside, within and between old and new developments, greenspace, the open countryside and protected landscapes. Also as per the Defra & Natural England policy paper, the Nature Recovery Network.
- Reviewing Policy in light of Covid and Brexit.


If possible please also give your views on key Options, eg for Climate strategy, Build quality and design, New sites, Greenfield development.

Hi again everyone! I wonder how you remember things? Do you make lists, write a note on your hand, set an alarm? In the old days, people even used to tie a not in their handkerchief! Many of you


#### **Thank You**

#### Letter from Chris Dudgeon, Vicar in Odiham

One of my favourite quotes is by Corrie Ten Boom, who said this: 'When a train goes through a tunnel and it gets dark, you don't throw away the ticket and jump off. You sit still and trust the engineer.'

We're all going through uniquely difficult and challenging times at the moment, with Covid-19 resulting in the loss of loved ones, restrictions on our freedoms, worsening mental health issues, and increased unemployment and financial hardship for so many.

It can indeed feel like we're going through a dark tunnel.

Corrie Ten Boom was a Dutch Christian, who lived through the most extreme suffering. During the second world war, she and her sister were caught helping Jews escape from the Holocaust, and as a result they were sent to Ravensbruck concentration camp, where her sister died. Corrie survived and her quote about 'sitting still and trusting the engineer' when we're going through a dark tunnel, was born out of her own experience, and refers to trusting God when things seem particularly bleak.

Sometimes trusting God when in the midst of dark times can seem particularly hard. But Jesus, who endured the most terrible suffering on the cross because of his love for us, tells us that as we trust him, as we walk with him, he will carry our burdens and restore us.

In Matthew's gospel he said: 'Come to me, all you who are weary and burdened, and I will give you rest. Take my yoke upon you and learn from me, for I am gentle and humble in heart, and you will find rest for your souls. For my yoke is easy and my burden is light.' (Matthew II: 28-30)

So as we progress through this dark tunnel that we currently find ourselves in, let's turn once again to God, and put our trust in him afresh each day.

One way of doing this is simply to speak to God in prayer, saying that we don't know what's going on, things are difficult, but we trust him – and we need his help.


Another way of turning to God that I find helpful is to read the Psalms in the Bible. These are full of references to how as we put our trust in God, so he restores us, takes away our fear, helps us, and renews our hope and joy.
