20/21/028 Public Participation Period

There were no members of the Public in attendance

20/21/029 Apologies

Apologies were received from Judith Jesty and Jenny Stowbirdge

20/21/030 Declarations of Interest and Grant of Dispensations

Cllr Weld declared an interest Items 5, 10 and 11, which was the 6/2020/0505 Bindon Range, Lulworth correspondence and the Local Plan consultation.

20/21/031 Minutes of the previous meeting held on Tuesday 17th November 2020

It was **resolved** that the minutes of the meeting held on Tuesday 17th November 2020 were an accurate record of that meeting and were duly signed by Cllr Pinnock.

20/21/032 Unitary Councillor Report

- a) The monthly report was circulated prior to the meeting via email.
- b) The 5G trial is still in progress.
 - i) The Council is very busy with Lockdown 3.0 and the vaccination rollout. 2500 Care home staff have been vaccinated and they are looking at now starting to vaccinate the domiciliary carers and personal assistants. The Purbeck Hub is based at Wareham Hospital which covers East Lulworth. The Clinical Commissioning group are given the vaccines and they distribute it throughout Dorset. This has resulted in local clinics unable to foresee how many vaccines they will get at certain times. At present there is only one booked clinic at Wareham, but this will change when more arrive. When the current top four vulnerable groups are done, they will then look at key worker groups such as teachers. It was asked if there has been any news on the mobile clinics. Currently only Pfizer vaccines are being used, which needs to be stored at extremely low temperatures, therefore at present they are unable to run mobile clinics. If people are unable to travel into Wareham, there are networks of people who can help with transport.
 - ii) It was asked what is classed as local when it comes to travelling for your daily exercise, there isn't a limit but it has to be done in a safe and sensible way.
 - iii) There are plenty of volunteers for the Purbeck Hub but they will communicate via social media if they need more people. The Hub has been set up as a ticketing event by using EventBrite, this site can be used by both volunteers and people booking their vaccinations. It was explained that there is intense pressure across the system, part of the reason for encouraging people to stay local is to prevent road traffic

accidents as there aren't any spare hospital beds. **Action:** The link would be forwarded to members of the Parish Council.

20/21/033 Planning Applications, Planning appeals or Tree Works

6/2020/0505- Binford Range, Lulworth Camp, BH20 5QS. Erection of a 25m Telecommunications Mast together with 4 cabinets, compound fence, 2 transmission dishes and ancillary development.

20/21/034 Highways and Footpaths

a) Bypass update

There was a Community Liaison meeting with the MOD, unfortunately Cllr Pinnock was unable to attend. The Parish Council will need to put in a formal request in order for the project to proceed. Cllr Miller will seek advice from the Head of Highways, as there are various cost implications to see whether it can be formally adopted. These include undertaking a traffic survey which involves putting strips on the road to record the amount of traffic and the speed of the vehicles. The major problem is that County has no available money, especially now due to Covid. Another option is to consider reducing the speed limit to 20mph. The criteria for this is laid out in the monthly report. It was suggested to contact Highways for ways to improve speed reduction.

20/21/035 Defibrillator Issues

20/21/036 Recruiting Parish Councillors

20/21/037 Lockdown 3.0

The DorsetTogether helpline (01305 221000) for vulnerable people is still available, one of the services that they provide is to signpost individuals to support and help with items such as shopping, prescriptions and access to food. As always, it was reminded that it is important to look out for neighbours who may be struggling.

20/21/038 Correspondence

- a) Correspondence Report - to receive and note the items on the report. Within the Correspondence Report it mentioned the Car Parking Permit Survey. It was confirmed that the deadline was 6th December.
- b) 2021/22 Precept Request. The Final Precept Notification form will need to be returned by 31st January 2020. **Noted.**
- c) COVID19 Vaccination Message Campaign. The simple messaging is: The NHS will get in touch when it's your turn to be vaccinated. **Noted.**

- e) West Lulworth Area Operational Plan. Action plan to manage the risk to public health due to COVID-19, trigger levels for implementing this plan will be established based on the current government guidance for social distancing. **Noted.**

20/21/039 Consultations and New Items for Discussion

- a) Consultation on Dorset Council Climate Emergency Strategy - SURVEY. This is to find out what you think about the proposed Climate and Ecological Emergency Strategy and Action Plan, which sets out exactly how Dorset Council intends to help tackle climate change. The closing date is 20th January 2021. **Noted.**
- b) Consultation on Tourist Information Centres (TICs). This survey focuses on the remaining three Dorset Council TICs in Dorchester, Sherborne and Wareham. The consultation period runs from 19 October 2020 to 3 January 2021. **Noted.**

- c) Fwd: Purbeck Local Plan Proposed Main Modifications consultation 13 Nov - 8 January 2021- TPC. Following hearing sessions last year, and a Post Hearing Note prepared by the Planning Inspector, the council has prepared a schedule of proposed Main Modifications to the local plan which are considered to be necessary to ensure that the plan is legally compliant and/or sound. **Noted.**
- d) Fwd: Purbeck Community Infrastructure Levy Draft Charging Schedule proposed further modifications 13 Nov-11 December 2020 TPC. Responses should be made by 11.45pm on 11 December 2020. **Noted.**
- e) Ecological Emergency Strategy Consultation. Dorset Council has a key leadership role to play in tackling climate change and dealing with its consequences, but we can only hope to make a real impact by working closely with communities, organisations and individuals. Part of this is finding out what you think about our proposed Climate and Ecological Emergency Strategy and Action Plan, which sets out exactly how we intend to help tackle climate change. The Consultation closes on 20th January. **Noted.**
- f) Dorset Council is consulting on the admissions arrangements for the academic year 2022 to 2023. The consultation runs from Thursday 12 November 2020 to Wednesday 23 December 2020. **Noted.**
- g) Consultation on Local Plan. It will open on 18th January and will run for 6 weeks. If any Parish Councillors have any comments, they need to send it to the Parish Clerk who would formulate a response. Although no housing development is planned for East Lulworth, some of the policies could affect the village. The plan can be found online and there are paper copies available in the main libraries. Podcasts have also been done to make it more accessible.
