




Family Service at St Leonard's Church, Cliddesden 19 March at 11,15am

This consultation closes at 11:45pm on 2 March 2023

THE BOROUGH RESPONSE will include a letter from the Council Leader/ group leaders, and a detailed technical response to Consultation questions. Both documents will relate to discussion at the Economic Planning and Housing Committee (EPH) of 9th February – and will be made public once agreed. Everyone is urged to make their own response to the Consultation.

'STANDARD METHODOLOGY' FOR CALCULATING HOUSING NEED

WHITCHURCH TOWN COUNCIL has played an active role in discussions. Their published response includes:

'Para 61 We strongly support an objective assessment of local housing need but NOT by using Government's Standard Housing assessment Method (SHAM) – which is NOT objective – being flawed in concept, construction and application. The defects include:

- Use of 2014 based national household projections
- Use of partially estimated 14-yearold data inputs
- Ignoring the up-to-date results of the 2021 Population Census
- Use of an economically illiterate affordability concept which artificially increases figures by up to 33%. This approach has been rejected by the Tillingham Hall planning inquiry, the Bank of England and current market realities, which all demonstrate that house prices are dependent on the cost and availability of credit and not marginal changes in housing supply.

'The objective assessment of local housing need should be based on well-developed demographic cohort survival models such as the Chelmer model, used and tested at numerous examinations in public.

'The Standard Housing Assessment Method should be discarded as completely flawed in concept, construction and application.

'We strongly support Theresa Villiers and the other 100 Members of Parliament in their endeavours.'

BOROUGH COUNCILLORS OF EPH (Economic Planning and Housing Committee) have previously been unanimous in their rejection of the Standard Methodology.

Councillors of 9 Feb EPH agreed 'the "SHAM" not fit for purpose'. 'What is needed is a mandatory, objectively assessed need; a locally accountable, locally derived housing figure based on objective data – that reflects this borough's true position. Need to be very clear what our evidence base can be.'

Despite Gove's pledged intentions, Planning officers' report confirms that nothing in the Consultation proposals is likely to much alter Basingstoke and Deane's housing figures.

This in the main because of (1) insistence on retaining the Standard Methodology and (2) restricting the potential scope of 'exceptional circumstances' by giving very specific examples – two exceptional circumstances, and three constraints which may be considered – none of which apply to Basingstoke.

SEEKING EXCEPTIONAL CIRCUMSTANCES

The rapid growth of Basingstoke has been much discussed – including in Maria Miller's 'Slow it Down' petition. This from its 1961 designation as a London over-spill town, to its part in the South East Diamonds for Investment & Growth Partnership which – 2006 onwards – sought to provide the majority of economic and housing growth in the south-east.

Re the former, '*localhistories.org/a-history-of-basingstoke*' says: the plan called for 37,000 people to be moved from London to Basingstoke. The town's population rose from 16,000 in 1961 to 75,000 by 1981.

This was again raised at the EPH meeting... 'How to identify characteristics of our population?

To consider Basingstoke as a London overspill town...

To recap... Historically the town's population has been artificially supplemented, and the consequences of that are ongoing. The profile of growth over the last 60 years means additional pressures compared to a town which has grown organically.

Considering other London overspill towns, citing e.g. Milton Keynes and Harlow. [Note both New towns, and also noting the eight London New Towns as designated by the 1948 Act: Basildon; Bracknell; Crawley; Hatfield; Harlow; Hemel Hempstead; Stevenage and Welwyn Garden City.]

To then consider Basingstoke in relation to such towns to understand the differences.

How the extra pressure from forced growth impacts on the constraints of Basingstoke's natural resources – its aquifers and rivers [at a location not initially planned for such growth]. Basingstoke's combination of exceptional demographics and environmental constraints require differences in how future growth is planned.

County deal update The government has welcomed the proposals put forward by HCC and others for a Pan-Hampshire County Deal, including a directly elected mayor and extensive devolution from central government. 20mph review Following last year's consultation – and the work of a HCC 'task and Finish group' – recommendations are to make it easier for communities, who wish to do so, to promote speed reduction schemes (30 to 20mph). The proposals will be considered for approval in June.

Roads Demand for Highways services far exceeds capacity at the present time, and work is having to be prioritised so that the highest risk issues are repaired first. This includes the use of temporary 'infill' repairs to remove major potholes, these can be addressed later on a longer term basis. One of the priorities now is clearing ditches and grips to help alleviate surface water flooding and ice problems in high risk areas.

She is on track to recruit her pledged increase in police numbers by 600 by the end of March this year; her new budget has added an additional 50 officers to these numbers, to be funded through the Police Precept of the council tax.

Cliddesden Primary School

S ports events and workshops are the theme for this edition and what an exciting month it has been.



Four of our Year 2 children demonstrated their hard work at Basingstoke Gymnastics Club. They performed two routines: a floor routine and a body management routine which tested their strength and flexibility. The children all demonstrated their routines individually in front of an audience and showed a lot of confidence. After, they all got the opportunity to use a variety of equipment. Their favourite parts were swinging on a rope, bouncing on the trampoline into a large foam pit and climbing tall mats that were taller than Mrs Jordan! Cliddesden came 3rd out of 9, which is a fantastic result against large schools.



Some of our year 5 and 6 children took part in an Indoor Athletics competition at Brighton Hill Community School. Nine local schools took part and we finished a respectable 5th place. This is an achievement as in previous years, 8th place has been our highest.

Some of our children came first in their races and skills events. We achieved the joint highest scores in the Girls 3-Lap Sprint and the Triple Jump competitions. The effort everyone put in was excellent and the teamwork and encouragement the children gave each other was wonderful to see.



A group of Year 5 and 6 children enjoyed an afternoon in the sun running this years cross country at Down Grange. The children raced against over 100 competitors and demonstrated fantastic perseverance to complete the 1.5 mile course. The children overcame their nerves at the beginning to show grit and determination right until the end. Pacing their races carefully and remembering to sprint all the way to the finish line!

Finally, Cliddesden's netball team battled well to a 7-4 victory over a very determined opposition from Park View. We showed excellent teamwork, determination and fair play. We were extremely proud of the whole team. This victory means we have qualified for the finals with another game still to play, we hope to finish top of our group.

STEM Coding



Carl Webb from SATRO visited the school to run STEM Coding workshops with Beech and Chestnut classes.





The children followed instructions on iPads to build a model using Lego Technics. Once the model was complete the children used coding instructions on the iPads to make the models move. Beech Class made windmills and racing cars. Chestnut Class built earthquake simulators and made buildings that had to withstand a simulated earthquake. The workshops allowed the children to explore simple algorithms and use sequence, selection and repetition in programs.



STBeech Class invited their families to come and share a Great Fire of London afternoon. We began by performing 'London's Burning' as a round. The children then became history experts and informed their families of what happened in September 1666. Working with their families the class then followed their house designs and created amazing houses using attaching techniques they have learnt in DT.



Year 1 and 2 had an exciting day going back in time to 1666. They were immersed in Cheap Street in London as urchins. They had to go to the different workshops and work very hard to ensure they might get a crust of bread to eat.

Workshops:

- 1. Scriveners they made ink and wrote using a quill.
- 2. Printers the children had to fold and sew newssheets together.
- 3. Potters they made plague charms from clay to scare away the plague.
- 4. Chandlers the children made candles (luckily from beeswax rather than smelly tallow!)
- 5. Soap makers the children had to grind the soap flakes and herbs to make a soap.
- 6. Apothecary the children were very good at acting out a variety of illnesses and even death! They then took it in turns to collect the correct herbs and make a remedy for the sick. The barber surgeon was also visiting ready to cut hair, pull out any teeth and even remove limbs!
- 7. Cordwainers the leather works luckily the children didn't need to mix the animal skin with urine and faeces. Instead they used hammers and denting tools to mark their initials and designs on a leather bookmark.

As the children moved around the different workshops along the street they heard lots of gossip about the fire. The town criers kept everyone updated with local news. Suddenly many rats appeared all over the street because they were escaping the fire from further afield. As the children were working some embers set fire to a building nearby. We saw smoke so had to create a bucket line to take water from the well to the fire. Then the Duke of York gave the street some grenades to blow up some houses to make a fire break. The children also used fire hooks to pull buildings down. Eventually they had to escape London.

In the afternoon the workshops became sites for archaeology. The children took turns to excavate trays with brushes to discover artefacts that were left after the Great Fire had extinguished. As the children sorted through the debris they thought about whether the workshop was burned, blown up or pulled down. They also decided which workshop they had discovered. Having decided the occupation of each shop owner they checked the paperwork to see if they owned the building and had a licence to practice.

A fantastic day was had by all and clearly Key Stage One at Cliddesden are now experts in the Great Fire of London.


