12.1 The Planning Committee met on 28<sup>th</sup> July at 7:30pm. Attended by Cllrs Harper, Kentell, McDermid, Cooper, Wenban & Clerk (PO).

Planning applications received:

#### a) MC/22/1713 Land South of View Road Cliffe Medway ME3 8UE

Construction of 50 retirement homes comprising of 42 apartments and 8 bungalows with communal facilities, electric scooter store and management offices with associated parking, landscape

improvements and on-site allotments.

Formerly approved at 'outline' stage but refused on issues such as design. Some precedents following decision on Orchard site the previous evening and approval of "2.5 Storey" blocks on the Redrow site. OBJECTION raised on urban aspect of development on the village-built boundary and impacts between the surrounding site and this following its approval the previous evening!

#### b) MC/22/1771 Land to South of Existing Stables at Buddy's View Perry Hill Cliffe Rochester Medway ME3 7TX

Construction of a combined amenity and day room building

OBJECTION RAISED due to impact on adjacent PROW and further intensification of residential use on the site (plans do not show the further mobile dwellings to the north. Full appraisal required of the whole site and suggested a site meeting of the planning committee is held before a decision is made,

- c) MC/22/1808 3 Milton Avenue Cliffe Woods Rochester Medway ME3 8JS Application for a Lawful Development Certificate (Proposed) for a flat roof rear dormer, to facilitate conversion of the loft into habitable living space. NO COMMENT
- d) MC/22/1836 Land Rear Of 56 -60 Town Road Cliffe Woods Rochester Medway ME3 8JJ Construction of a detached dwelling with associated parking, cycle storage, boundary treatment and landscaping

OBJECTION RAISED re. overdevelopment of the site and out of keeping with the surrounding residential properties.

#### 12.4 Other Planning Issues:

- a) Trenport Land Cliffe Initial Outline Planning application for ACCESS (all other matters reserved for future submission when details will be available) see MC/22/0254. No progress on consideration of initial access only submission – update to Parish Council submission now required Cllr Harper/Clerk PO
- b) MC/21/1287 Redrow (Gladmans) site West of Town Road The application has now been approved by Medway Council. Development progressing, with highways and site issues and development concerns being raised with Medway Council.
- c) Esquire- MC/21/1694 (Orchard) South of View Road Due to timescale. further concerns raised with the Medway Council Planning Committee Agenda for 27/7. PERMISSION GRANTED BY MEDWAY COUNCIL despite concerns of the parish council and objection of Natural England (national planning policy states "development on land within or outside a Site of Special Scientific Interest, and which is likely to have an adverse effect on it (either individually or in combination with other developments), should not normally be permitted. The only exception is where the benefits of the development in the location proposed clearly outweigh both its likely impact on the features of the site that make it of special scientific interest, and any broader impacts on the national network of Sites of Special Scientific Interest"
- d) Draft Medway Local Plan awaiting an update as the publication of Draft, and Public Consultation will be further delayed, despite initial plans to publish in October 2021, with a possibility of regressing to the previous consultation stage if Medway Councillors want a significant change to the proposals. STILL OUTSTANDING LEADING TO APPLICATIONS AND PLANNING PERMISSIONS IN THE PARISH THAT WOULD HAVE BEEN UNLIKELY TO HAVE BEEN SUBMITTED OR GRANTED IF THERE WAS A PLAN.

#### 13.0 Cliffe and Cliffe Woods Neighbourhood Plan

Medway Council has completed a consultation on our Draft Version. The plan has now been submitted to a Planning Inspector for examination (September). and then the Steering Group/Parish Council will need to consider the inspector's comments and then proceed to a Referendum. If approved by a majority, it becomes Planning Policy for our area and is considered when future planning applications are submitted. There was some consideration of the NP in considering the Esquire 'Orchard' development, although not statutory at this stage.
