170. REPORTS FROM BOROUGH & COUNTY COUNCILLORS

Borough Cllr Cannon reported on the following issues:

ANTI SOCIAL BEHAVIOUR IN COMMUNITY CENTRE CAR PARK

I understand you are discussing this shortly but following the Clerk's email advising us, the local borough councillors of these incidents, I contacted Des Keers who is the TMBC Cabinet member for Community Services who suggested we should activate the Community Trigger Plan. This alerts the Community Safety Unit multi agency teams to the issue and will enable Alison Finch who is the safer and stronger communities manager at TMBC to create an action plan. This will involve a conversation with Police Inspector Terry Newman who will ensure there are staff in the locality when there is most need. He also suggested any additional intelligence is beneficial so residents and others need to continue to report any anti social behaviour in as much detail as possible. This will be in addition to the action with the police that the Parish Council have already taken and I'm also aware the KCC warden has separately spoken to a few residents about some of the incidents.

Des referred to a Community Safety Unit meeting at Holborough Lakes for this type of situation last year and suggested we might like to consider such a meeting here much as Nicola and the Parish Council mentioned in their email to us. He recommends the Parish Council, the ward borough councillors and Alison Finch should follow this up because even if there is a chance, at least according to the police, that angry residents may be present it will be beneficial for community reassurance if it can be demonstrated something is being done.

WEST KENT BUSINESS GRANTS SCHEME

Grants of £500 will be available to small and start-up businesses in Tonbridge and Malling when this scheme opens on 13 September. This scheme is geared towards business growth and/or carbon reduction measures. These grants have been made available through the government's UK Shared Prosperity Fund.

In January 2024 the next round of the Shopfront and Vacant Unit Improvement Scheme commences and the Cabinet have agreed to increase the maximum level of the grant from £3500 to £5000 to reflect the recent high inflation figures and the fact businesses are struggling due to slow growth in the economy.

LAND PARCEL NORTHEAST of 15 STATION ROAD

Unfortunately the period for call-in had expired before I received a request to call this in. However I am happy to support the concerns the Parish Council have in terms of parking at Station Road at the entrance to K Sports.

Other deterrents were discussed such as ANPR cameras, enhancing the current CCTV or changing the car par layout. It was agreed that the priority would be to arrange a public meeting with the police and other partners [as detailed by

borough Cllr Cannon], in the Don Carman Hall. The Clerk will contact the police to get some possible dates.

Ditton Parish Council supports the comments raised by East Malling & Larkfield PC:-

- 1. As a general point although described as "Aylesford" most of this site is in Ditton Parish with the main access via Leybourne Way and the secondary access currently being improved for vans and cars out to Station Road
- 2. It is hard to respond to the great number of documents and plans with some being hard to read on laptops.
- 3. It is noted reference is made to the proposal for a bus to run through the site and the Parish Council would appreciate details of the route proposed.
- 4. Reference is made to the straight public footpath running next to the railway from Station Road through to New Hythe Lane in this Parish which is also used by cyclists. Ideally this should be wider and any landscaping provided should be kept from growing from this site into the route of the path (MR91)

- 5. The Parish Council looks forward to the early opening of the diverted public path, MR492, out to Station Road where it should be marked with a public path sign.
- 6. The Parish Council remains supportive of the proposals for landscaping the former part of the mill pond north of M20. It looks forward to the work being completed and the provision of the proposed information board.
- 7. The Council notes the proposals for the future maintenance of the landscaped areas and these are welcomed.
- 8. It was understood the river path, MR91, from Millhall through to Aylesford village was to be improved as part of this development. How does this stand? Part of the route runs over the Borough's riverside open space.
- 9. It was understood that works were proposed to the Hall Road/Station Road junction. It is considered this needs progressing with the opening of Bellingham Way
