10	13/02/20	Silage / manure spreading	Reqs't	Out	Environment Agency	"The Parish Council asks for guidance regarding the spreading of silage / liquid manure by farmers. I have been informed that application of liquid manure commenced after dark on the evening of Friday 7 February and continued throughout the day on Saturday, with a storm forecast for Sunday. The ground was already waterlogged and there are springs in the vicinity of the field in question, which flow down to culverts which lead eventually to the River Winniford. There are concerns that water run-off from the field will now be full of liquid mature, which has not permeated into the ground due to it being waterlogged. Not only is this a waste, but the manure it will flow down the springs / culverts / drains into the river and potentially cause pollution. DEFRA guidance states that the silage / manure should be ploughed in within 6 hours of application but clearly with fields waterlogged this was extremely unlikely to happen. We realise that we need to live in harmony with farmers and that farming needs to be supported - but surely this is poor land management by the farmer. We would like to know how this situation could be avoided in the future. Does the Environment Agency have policies and guidance for farmers? And if so, how are they enforced?"

15	18/02/20	A35 Communities	Reqs't	Out	Parishes on A35 between Dorchester and Honiton	<p>"I am writing to you because your parishes / communities are, like Chideock, impacted by the A35 Trunk Road.</p> <p>Chideock Parish Council would like to arrange a meeting with other parishes to discuss our common issues with the A35 (e.g. speed, volume of traffic both cars and HGVs, air pollution) and to formulate a joint approach to Highways England.</p> <p>Please will you present this request at your next meeting and let me know the outcome.</p> <p>I look forward to hearing from you."</p>	Replies so far: - Symondsburry, Bothenhampton & Walditch, Uplyme, Widworthy (Wilmington), Char Valley
16	31/01/20	A35 Diversions	Info	In	A35 Diversion Group	<p>"We are writing to all the Councils affected by temporary unexpected closures of the A35 between Bridport and Axminster, such as traffic accidents, flooding, or other blockages. Your Council is responsible for an area that is either directly on the A35 or the designated diversion route defined by Highways England (see attached HE map), or is affected by traffic which self-diverts through smaller local roads.</p> <p>In November 2018, following a public meeting with Martin Underhill, the Dorset PCCC, a small volunteer action group worked to identify possible actions that we, the public, could take to reduce the impact of temporary unexpected closures of the A35. After a year or so of discussions with HE, PCCC and local MP, we have reduced our expectations but now have a proposal.</p> <p>We have set up an email alert that is notified by HE through its NILO system, of any major blockages of the local A35 that could lead to traffic being diverted deliberately or choosing to divert along other routes in the local area.</p> <p>Our proposal is that each Council should receive this information and take whatever steps it feels appropriate. Such steps might include notifying local businesses of the impending congestion, arranging for announcements in shopping centres or health centres so customers, clients, or services can plan their local journeys, contacting holiday centres to inform tourists, or whatever seems appropriate for your area.</p>	
						<p>We were originally hoping to be able to activate suitable volunteers to stand at junctions and deter drivers from taking routes away from the official diversion across the narrow lanes and causing further congestion, but this was not supported by the Police. Probably a very sensible objection, especially in terms of safety and lack of authority. We can't stop drivers from using their Satnavs to plot an apparently shorter route, but there are trials taking place where Satnavs will receive instructions that tell drivers to follow the diversion routes (even if the Satnavs calculate quicker routes).</p> <p>So, if you feel that this may be useful for you, and you don't have your own alert system, please send me an email address that you would like to be informed and it will be added to the distribution list. Obviously, we have to limit the number of email addresses we can support because we don't want to be categorised as 'spammers', but it seems we should be able to get up to about 100.</p> <p>I have attached samples of the output from NILO that gives blockage details. As you can see, the NILO area covers more than our local patch so wouldn't always require you to jump out of bed and ring bells!!"</p>

Chideock Parish Council has consistently been involved in working with the relevant authorities regarding pollution in Chideock since May 2007 when an Air Quality Management Area was put in place by the then West Dorset District Council. Since 2007 there have been 4 different parish councils, with varying personnel, but the approach taken has been consistent over the period. In regard to specifically answering the two issues that you have raised it is important to state that Chideock Parish Council is not directly or legally responsible for carrying out measures to prevent or reduce pollution. However pollution and it's impact upon the village and its residents and visitors is a matter that councillors take exceptionally seriously and as such are vigorous advocates in seeking to get the relevant authorities to do something about it."	

						<p>Therefore in response to your questions :</p> <p>1. Dorset Council has a statutory responsibility and duty to monitor and put in place an annual plan regarding measures being taken to attempt to reduce pollution levels in Chideock. This plan is produced in November of each year and is submitted to the Department for Environment Food & Rural Affairs (DEFRA) which has a duty and a responsibility as the statutory government agency regarding pollution. If you wish to see this plan please contact the Environmental Health team at Dorset Council - envhealthteamb@dorsetcouncil.gov.uk</p> <p>2. Highways England is responsible for the current speed / pollution control pilot project that is currently being carried out on the A35 at Chideock Hill. The Parish Council is very aware of the current limitation regarding the lack of speed enforcement and as such councillors are concerned that any subsequent data may be invalidated. Since October 2019, the Parish Council has written to the Police, Highways England, DEFRA and the Department for Transport specifically about the enforcement issue and to date we have had no positive response from these individual bodies. In conclusion, the Parish Council has worked tirelessly to raise these issues and will continue to do so on behalf of the village. If you wish to raise further issues then please do not hesitate to contact us. There will be a short article in the March edition of the Chideock News to update the village on the current speed trial and the actions taken by the Parish Council."</p>

23	23/02/20	Advice on Public Health Issues	Follow-up	Out	Cllr Rebecca Knox, cc Cllr Christopher, Cllr Flower, Chris Loder MP	<p>"Parish Council refers to the letter sent to you dated 7 August 2019 (attached) concerning air pollution in Chideock.</p> <p>To date The Council has received no response to this letter nor, sadly, even an acknowledgement of the concerns raised for the well-being of Chideock residents and the request for advice on this Public Health issue.</p> <p>To summarise:</p> <ul style="list-style-type: none"> - Chideock has been defined as an Air Quality Management Area (AQMA) since 2007 with monthly nitrogen dioxide (NO2) monitoring results being published on the Dorset County website. - Since 2007 the pollution levels have steadily worsened, with western parts of the village recording levels of NO2 well in excess of the statutory levels set by the Government. - The Parish Council continues to urge Dorset Environmental Health to commence short term monitoring for particulates PM2.5 and PM10 to determine whether or not these also exceed Government guidelines. . - The Parish Council requested (and still awaits) guidance from you on what advice to give villagers when asked how best they may reduce the damage to their health potentially being caused by these illegal levels of pollution. <p>The Parish Council hopes that you have now had sufficient time to consider these requests and look forward to a meaningful response from you shortly."</p>

However, some data that Public Health Dorset have reviewed and provided is available at https://public.tableau.com/profile/public.health.dorset#!/vizhome/AirPollution_10/AirPollutionStory</p> <p>In the recent formation of Dorset Council, a large proportion of workloads and responsibilities were redistributed and disappointingly some timelines for completing work slipped. The 'WDDC' ASR was among this but fortunately I now have some extra support to assist me with the air quality reporting, the new Air Quality Action Plan and also updating of the Dorset Councils website.</p> <p>I apologise again for the delay, and I will of course continue to keep you informed when I receive any updates.</p> <p>In the meantime, in the pursuance of forming a joint working group for the Action Plan, could I ask if CPC will consider some measures that they would like to see included in Action Plan, and forward them onto me? This was largely caused by water run-off from the field on the north side of the A35, which has been ploughed up and down the slope, not on the contour. The flooding was made worse by the lack of any drainage ditching at the boundary with the A35. Given that the water contained soil the flooding caused the gulleys on the A35 to be blocked with silt, thus exacerbating the flood.</p> <p>At that time the field in question was owned by the Highways Agency and it is understood that the Highways Agency contacted the tenant regarding the direction of ploughing. In subsequent years contour ploughing was carried out. The land has now been disposed off by Highways England, presumably to the Chideock Manor Estate, the original owner.</p> <p>In late December 2019 flash flooding again occurred and it is noted that the field has not been ploughed along the contour line. To make the situation worse, hedges on both sides of the A35 towards Bridport had been flailed a day or so before and the detritus had not been cleared up – this blocked the gulleys. Residents cleared the debris but then the gulleys and collection chamber were blocked with silt. There has been at least one further occurrence, on Sunday 9 February 2020.</p>
						<p>Most of the water exits onto the road by the Broadmead bus shelter on the north side of the road. It doesn't affect the Broadmead properties - its the Old School House, St Antony's, Bilberry Close and Park Farm Bungalow.. And before you ask, yes there are sandbags but it happened too fast for these to be used. Interestingly water coming down the Park Farm track dissipates without adding to the problem, or so have I have told.</p> <p>The road and pavements in the vicinity are covered in mud.</p> <p>There appear to be several actions to be taken</p> <ul style="list-style-type: none"> - ensure that contour ploughing is always used, to stop excessive water run-off and the associated soil erosion - provide a ditch at the boundary of the field and the A35 - clarify responsibilities for clearance of mud from the road and pavements, and how it this can be enforced - clarify responsibilities for clearance of hedge flailing debris from the road at the time it is created, and how it this can be enforced <p>Chideock Parish Council asks you to look into this, or to refer it to the appropriate person / agency, and advise as to how this can best be taken forward. As you know, the Parish Council does not have any power in such matters and is not seen to have any authority.</p> <p>I attach a map showing the field in question.</p>
