The Locum Clerk requested that the resignations be confirmed in writing, and that she would advise MBC of the casual vacancies and that the Parish Council had become inquorate.

Before the meeting closed it was agreed that all remaining agenda items be deferred to September and that a resident would be afforded the opportunity to present his suggestions for The Old Barn, Lynch Bank, Detling. The information was received with interest. The resident was advised that due to the unusual situation now facing the council, to work with the community over the summer months, to engage interest and ascertain the level of support and that the matter would be on the council's agenda again in September.
