SE/24/00035: 94 Coltstead New Ash Green Kent DA3 8LW - Single storey rear extension. Cllr J Clucas PROPOSED that the Parish Council does not object to this application as long as it does not conflict with local planning policy. SECONDED: Cllr P Kirtley and AGREED.

SE/24/00132: Tanzematt Oak Farm Lane Fairseat Kent TN15 7JU - Raise the roof and extend the first floor. Single storey front and rear extensions. Porch (Cllr S Hobbs arrived) Cllr F Cottee PROPOSED that the Parish Council strongly objects to this application as inappropriate development in the Green Belt. The bungalow is situated in a rural lane in the Green Belt and faces an area of Ancient Woodland. The street scene is characterised by dormer style bungalows in large plots, mostly built in the mid 20th century. The proposed development contravenes Policy GB1 of the SDC ADMP firstly by resulting in a massive increase in floor area of nearly 80% and secondly by a substantial increase in roof height of nearly 2m. The resulting increase in bulk would have a serious impact on the openness of the Green Belt in this area and would be completely at
