Re-alignment of the existing domestic drive

Following the comments sent to the Inspectorate after the last meeting the clerk, after discussion with the chairman, sent the comments below to ensure there was no confusion regarding the position of the drive:-

As a site visit may not be possible the Parish Council would like to ensure the inspector is aware of the location of the proposed driveway in respect of the churchyard and burial ground. The churchyard is owned by the church and at no point does the proposed driveway border the churchyard.

The burial ground is owned by the Parish Council and lies in between the proposed driveway and the churchyard.

The Parish Council have no objection to the proposed driveway for the following reasons:-

- 1) It will not infringe in any way on the burial ground and as it does not border the churchyard there are no implications.
- 2) The Parish Council feel that the materials used in the proposed driveway are entirely suitable for the location.

Village Maintenance:-

- 1) Streetlight on Church Farm Way was reported by a resident as not working. Clerk has reported. Now confirmed as light 6.
- 2) Drain outside pub silted up photos sent No immediate safety defects or flooding at time of visit. Drainage issue has been logged and will be undertaken on cyclical maintenance programme to be undertaken by the end of March 2020. Clerk to report again as this was not before the end of March.
- 3) Drain by 18th Oxendon Road blocked photos sent No immediate safety defects or flooding at time of visit will continue to monitor through highway safety inspections. Drainage issue has been logged and will be undertaken as part of our routine cleansing programme to be undertaken by the end of March 2020. Clerk to report again as this was not done before the end of March.
- 4) The beech hedge by the burial ground has not yet been done due to illness. To be undertaken in September after the nesting season.
- 5) Public footpath CB5. The footpath is very overgrown and hazardous to walk on. The clerk to write to Arthingworth Estate and Swinfen Farmers to ask if areas can be cut back to allow access for walkers.

6) Drain on Kelmarsh Road – very wet even though the weather has been dry. LS to send photograph. Clerk to report.

"Last week a Range Rover drove up the lane whilst I was walking my dog at over 40mph and continued through the village at the same speed. Today myself, 4 year old son and puppy were pelleted by the tractor driving too close to the track whilst spraying the field with white pellets. I stopped him and he showed little or no remorse. Their tractors drive through the village at great speed with no consideration for the villagers. I appreciate at this time they have to go about their business, but they need to consider the people that live here. I fear an accident is just waiting to happen."

The complaint was noted by cllrs. and the situation to be monitored.
