- 1 APOLOGIES FOR ABSENCE Cllr Anna McGovern
- **DECLARATIONS OF INTEREST –** Cllrs Sandra Fenney declared and interest (Cliffe Memorial Hall), Vivienne Walton and Sue McDermid (Cliffe Woods Community Assoc)
- **ADJOURNMENT-** Two members of the parish were present for the meeting. They addressed the parish council regarding a recent planning application to their property. Cllr Wenban declared an interest here and did not take part in the discussions.

 - Annual Playground Inspection Report to be carried out in September rather than May (Clerk PO is seeking advice from insurers)- Clerk PO sought further clarification and there would be no impact on the policy. Cllr Wenban proposed to delay the inspection until September, seconded by Cllr Cooper- ALL AGREED
 - Play equipment inspection one day course to be arranged with Allhallows PC- Cllr Walton proposed to accept the training, seconded by Cllr Wenban- ALL AGREED.

 - Meeting with PCSOs regarding Motorbike nuisance at the Recreation Ground (issues and potential solutions report circulated, but expensive not comprehensive)- NOTED
 - CCTV in Village Club disabled through hacking. Now restored with local recording. Remote
 access not currently working. CCTV contractor to provide quotes for upgrade to cameras and
 recording unit for future consideration.- NOTED.
- 3. The charges for Cliffe Recreation Ground pitches and Changing Rooms need to be agreed now that football has returned (it is suspected that Rugby will not return until the new season. Clerk (RFO) will report after checking with teams and will make a recommendation about charge and applicability. Cllr Farrelly proposed to keep the rents the same as last year due to COVID, seconded by Cllr Keates- ALL AGREED

 Details pursuant to conditions 2 (materials) and 7 (electric vehicle charging point) on planning permission

- b) Buddy's View Additional residential caravans. Recommended for approval at Medway Planning Committee (28/4). Concerns about lack or information/incorrect, not showing other properties on site. Suggest a site visit, correction of details. Clerk has contacted Medway Councillors (Strood Rural) about concerns- **Deferred by Medway Council**

12 Cliffe and Cliffe Woods Neighbourhood Plan

The report of the Neighbourhood Plan Steering Group (29/4/21) will be submitted.
