TC has emailed the landowner about cutting back the tree, they said it was going to be done the next day, but nothing yet. d) I.L met Glynn Shaw whilst he was investigating a site for the replacement of the town twinning sign. Apparently the new sign will incorporate 3 flags and the names of the twinned towns. The current sign is placed on the Overton Road to the north and on the opposite side of the road to Lower Barnes Road. The width of the new sign is 1.8 metres and it will need to be 7 feet above the pavement. Mr Simon Hoare – Supermarket Development 60 members of the public

#### **Super Market Development**

The plans are for supermarket and a 200 space car park, with a 6 pump filling station. When a survey was carried out 212 people supported the petrol station and 79 were opposed. 146 supported supermarket and 150 opposed.

The developers are hoping to submit the plans within the next 10 days. Mr Hoar said that since July South Shropshire Housing Association to the rear of the site have agreed on the landscaped buffer that has been suggested. Mr Hoar also said that there was no Environmental Risk Assessment required. The access is all going to be off Dunn Cow road and the crossing at Rocks Green, there is also going to be a cycle access. There will be improvements made at the junction to allow service vehicles easier access. The way that the car park has been designed it should cause no traffic problems for the residents. Mr Hoare suggested that 106 monies could be used for a contribution to Ludlow in bloom and he also asked LPC to consider what projects to be contributed to.

The Chairman thanked Mr Hoare for coming to update everyone and asked if anyone had any questions.

- VP said that she had done her own survey and people definitely said there was a need for a petrol station, but not necessarily a supermarket, also not necessarily on that site.
   Mr Hoare said that the household survey said that 45% rarely/never combine food shopping and other retail experience, suggesting that it would not stop people going into Ludlow to shop.
- Comment was made that the 16 week planning cycle doesn't allow possible sufficient consultation.
  SH offered to come back to present further information. Everyone in the room was asked if they had
  received the telephone survey. Nobody said they had. SH said the company conducting the survey
  wouldn't have said it was about having a new supermarket, but just ask questions about their
  shopping habits.
- GG cannot see how developments like this cannot be classed as causing Towns to dwindle. An out
  of town development will take trade of Ludlow.
- There may be new jobs created, but there would also be jobs lost in shops in the town, it would
  create a problem for the independent shops. There needs to be jobs created for young people. A lot
  of people who live in Ludlow don't shop here in the independent shops. There are two ends of the
  spectrum, those on a very low income and the more affluent.
- Comment was made that the telephone survey being made to landlines and not mobiles, a number of
  people in the town use mobile phones so not a true representation of the people of Ludlow, many
  young people only have mobiles.

#### 8. Annual Place Plan Review

After looking at the information currently held on the place plan it was agreed for further investigation to be done. The deadline for submission to SC is early January, so comments to be collated from Councillors and returned.

#### 9. Planning Items:

**a)14/04608/OUT** Outline application (access for approval) for mixed residential development comprising 137dwellings; demolition of existing agricultural buildings; creation of vehicular access from the A49 Ludlow Bypass | Proposed Residential Development Land At Foldgate Lane Ludlow Shropshire. After discussing the application and taking into account the views from the public, the following objection was agreed to be submitted:

- The application is not within SAMDEV
- The measures proposed to preserve Foldgate Lane from traffic are impractical. Although the access route to the site is via the A49, the plans to prevent access via Foldgate Lane are insufficient to prevent vehicles using this shorter route to Ludlow; it will lead to unacceptable traffic problems.
- The Sheet Road/Tuffins traffic island lies directly north of the proposed A49 slip road which would form the access point for Ludlow. Very close to the roundabout is the access to not only the main petrol station for Ludlow residents and passing traffic on the A49, but also to other busy commercial premises; consequently there are frequently considerable traffic queues at the access to this area, as the entrance is via a narrow and constricted access road. Consequently the increased number of vehicles from this development will exacerbate this problem considerably. The amount of local traffic will also be increased at this junction by the 80 dwellings that recently have been given planning permission at the Sheet.
- Storm water drainage from the site is already a significant problem that will not be resolved by this development. There is a concern that the drainage system from this proposed site would worsen the already inadequate drainage, particularly the sewage system.
- The cost of maintaining the considerable open space and parks areas will be considerable and will increase the risk of later applications for more housing within the site.
- The land if Grade 2 agricultural land and Government policy is to minimise development on quality farmland.
- There will be a considerable and deleterious impact upon the Grade 2 listed Foldgate Farmhouse and its associated buildings. This extensive development will surround the property and transfer it from its historic setting into an urban estate. None of the new building materials will be able to harmonise or complement the buildings or their setting thus permanently degrading its architectural importance. The site will also adjoin the boundary of the Steventon Conservation Area which runs down to the River Teme and any new estate will readily be viewed from Whitcliffe Common on the opposite side of Ludlow, thus despoiling the open aspect towards Clee Hill."

b)14/04807/FUL Application under Section 73a of the Town and Country Planning Act 1990 for the external lighting to serve car park of approved planning applications reference 13/01449/OUT and 13/04985/REM | Land On The East Side Of Foldgate Lane Ludlow Shropshire: It was agreed that the following comment be sent: Ludford Parish Council are pleased that the applicant has been requested to submit a full planning application for external lighting for the new Pets at Home Store off Foldgate Lane, as the original lighting was totally unacceptable, causing a severe diminution in residential amenity in the area with the light pollution impacting adversely on neighbouring homes in Foldgate Lane and Greenacres as well as the neighbouring, pub, hotel and residential care home. Ludford Parish Council would expect the new scheme to minimise light pollution by cutting out all light spill onto neighbouring properties and Foldgate Lane, and would expect the level of lighting on the site to be no brighter than that provided for the car parks at the Squirrel and the Travel Lodge. Further, we would also request that the external lighting be switched off when the store is closed. We are unsure as to whether the new lighting scheme now in place is what is being proposed as a permanent solution. If so, it represents a marked improvement on the original scheme with regard to the amount of light being emitted, but there is still too much light spill onto Foldgate Lane, caused mainly by the lamp posts being sited in the hedge and too close to the lane. This is an issue, not only on account of the suburbanisation of the last rural lane in Ludford Parish but also because it will have an adverse effect on wildlife living in the protected hedgerow and the summer bat roosts in the TPO oak trees along the lane. Unless the lighting is reduced to the current level or less and the issue of light spill onto Foldgate Lane is addressed, Ludford Parish Council would object to approval being given.

# 3. Chairmans Report

Ludford Parish surrounds Ludlow to the east and the south and comprises a number of communities, namely Rocks Green, The Sheet, Steventon with Foldgate, Ludford and Whitcliffe. Development in recent years in Ludford Parish

Ludlow itself has insufficient land available to provide for further, major expansion. Therefore plans to provide for the expansion of Ludlow have impacted directly on Ludford Parish. In recent years we have seen the development of the Foldgate Lane site, the Eco Park at the Sheet and over 90 new affordable houses at Future Development in Ludford Parish - SAM-Dev

The main task for the Parish Council during the past year has been an input to the SAM-Dev plan of Shropshire Council, a plan that provides for development for the period 2006 to 2026.

The SAM-Dev plan provided for 875 new dwellings between 2006- 2026. 517 have already been built or have received planning permission since 2006. This leaves a residue of 358.

The majority will be provided in Ludford Parish, 200 to the south side of Rocks Green and 80 at The Sheet, to the east of the Eco Park. A planning application for the 80 dwellings at The Sheet has already been submitted. The SAM-Dev plan also includes 6ha of employment land. 2.5 ha are located to the east of the Eco Park, behind the 80 houses proposed there and a further 3.5 ha to the south of Sheet Road - LPC is totally opposed to the development to the south of the Sheet Road as LPC has continuously requested that any development outside the Ludlow Town Council boundary should take place in the area between The Sheet and Rocks Green, to the North and East of the Eco Park. L.P.C. has also expressed major concerns about the lack of sustainable facilities to support the additional developments proposed. LPC has collaborated with Ludlow Town Council in submitting views on SAM-Dev to Shropshire Council as this strengthens the local views. The SAM-Dev plan will not be in place for some months, as it is being processed by Shropshire Council. In the meantime Ludford, as also are many other parishes, vulnerable to development proposals until SAM-Dev is in place. The planning application for development to the east of the Eco Park, including 80 new houses is an example of this threat, as the grounds for refusal are slim.

# **Ludlow Hospital**

The proposal to build a new Ludlow Hospital, on land at the north of the Eco Park was abandoned in 2013. To date the land has been retained by the Hospital Trust. Park & Ride Bus Service

The bus service has been reduced to a service every 30 minutes & also linked to town bus services in order to reduce operating costs for Shropshire Council. **Traffic Developments** 

The traffic lights at Ludford Bridge have been replaced and upgraded.

The Shropshire Council Speed warning signs have been used at Rocks Green and the Sheet, but not as frequently as had been anticipated.

The Parish Council has been presented with plans for a possible hydro generator for Ludford Mill.

Finally I would like to thank the staff and Councillors who serve Ludford Parish Council.

We welcome a new councillor, Geoff Crawley, who represents Rocks Green.

There have been a number of complaints about the Vic being moved from the museum and Mr. Chris Edwards from SC has said that the Town would be kept informed about the Vic being moved into the museum, it would also be in the press. Mrs Parry would like to see an improvement in the Park and Ride service. Currently it doesn't go to Beaconsfield, Ludlow School or Rocks Green. Mrs. Parry is also trying to get some work done to the play areas of the town as nothing has been done in them since SSDC ceased 5 years ago.
