Details pursuant to condition 9 (details of roof lights and external staircase) on variation of condition application MC/22/2165 - Variation of condition 2 (drawing numbers) of planning permission MC/21/3356 to reconfigure the approved first floor layout to provide a main family bathroom with vaulted ceiling over, reconfigured bedroom 1 to include a dressing area along with the en-suite; 3 rooflights added over en-suites to bedrooms 1 & 2, see drawing 21-29-P20 A together with roof space over garage to be boarded to provide an office space with external staircase and 4 rooflights. **Comments:** None

    Due before Medway Planning shortly, expiry date 10/12/22.
