## **Ampfield A3090 Speed Limit Policy Proposal**

ADOPTED 14 NOVEMBER 2016

## **Objective**

The A3090 and traffic volume and speed has a significant effect on the environment of Ampfield in the areas of the parish that it passes through. Questions from parishioners on speed issues along parts of the highway are a low level but constant concern, which Ampfield Parish Council (APC) has historically reacted to as and when they arise. The purpose of this paper is to propose a policy for speed limits across the length of the A3090 in the parish, which APC can adopt as a benchmark. It can be used as follows:-

- Communicate to the parish as a vision of what we would like to achieve, a tool to obtain views on the subject and focus dialogue on specifics
- Respond to parishioners who have complaints regarding speed issues
- Use as a benchmark when discussing A3090 alterations in the future with Borough and County Highways
- Set a context for individual decisions (e.g. the 2015 decision regarding the support for a Straight Mile 40mph limit)

APC have no power or responsibility to set speed limits. However, a coherent and agreed policy at parish level will be a useful tool in the framing of future discussions and decisions on the subject.

## **Proposal**

The tables on the following page break down the A3090 into different sections through the parish. They give the current speed limits with a proposal on how and why these should be either maintained or modified to fall within a long term policy.
