b. Athletics Track

At the WDC Planning Committee meeting on 12th December 2012 the Handy Cross development outline application was heard first and it was minded to grant permission but the application has to go before the Secretary of State, because it involves out of town retail development.. It was minded to grant permission for the Westhorpe application subject to various conditions including a grant of money for the Country Park.. The Athletics Track would need to be completed before the Handy Cross development could commence

Concerns were expressed as to where the sum of money will go as the Little Marlow Lakes Country Parks Community Partnership is not formally constituted. It was suggested that it could be held by the Parish Council.

Dominic Grieve, MP, has asked Eric Pickles MP to call in the athletics track application and it was resolved that the pc should write in support of this.

We have received a copy of WDC's updated Enforcement Plan.

Mrs Wallis spoke to BCC regarding Westhorpe Field. An Enforcement Notice has been issued.
