8	Abinger Common Playground <ul style="list-style-type: none">Councillors discussed the multi-play item which had been deemed unsafe when the contractors from Safeplay visited to do repairs. Cllr EB agreed to contact Safeplay and arrange a visit with an engineer to discuss the item on-site face to face. The Clerk was instructed to gain further quotes for a replacement to compare with Safeplay quotes and also look into grant funding for this item. Councillors agreed to budget £10K for 2022/2023 to feed into precept request for 2022/2023
