A steering group under the auspices of Farnsfield Parish Council have been working on a Neighbourhood Plan since 2014. The aim of the Neighbourhood Plan is to guide future development within the parish.

Neighbourhood planning provides the opportunity for communities to set out a positive vision for how they want their community to develop over the next ten, fifteen, twenty years in ways that meet identified local need and makes sense for local people (source: Dept. for Communities and Local Government. March 2014)
