4 Matters Arising from the above Minutes and any urgent business

- a) NCC Building Dunham on Trent Cllr I Atkinson enquired to the Chair if there had been any progress with the demolition of the building in his absence. Cllr Matthews stated that the situation remains the same – the high cost of removing the asbestos on the building prevents any further progress. The Parish Council cannot afford to have this work carried out and the Nottinghamshire County Council have not made any attempt to remove the building themselves.
- b) Bus Shelter, Laneham Road

 The Clerk had written to Karen Emery at Nottinghamshire County Council to inform her that the Parish Council had invited District Cllr M Jenkins to this meeting and that the matter would be reinvestigated with his support. The letter was read out to the meeting by the Chairman. The Chairman then informed District Cllr M Jenkins of the history of the case including the Site meeting held with County Cllr J Hempsall and a representative from the school. District Cllr Jenkins had received background information via the Clerk and had made contact with Karen Emery to find that nothing had changed since the bus shelter was refused in 2002. He had also made telephone contact with County Cllr J Hempsall who said he is attempting to reduce the speed limit outside the school to 20 mph. District Cllr Jenkins enquired about the exact location intended for the bus shelter and said he will visit the site himself and report back to the Parish Council. Action: District Cllr M Jenkins
- c) Footpath Cocketts Hill Nothing to report
- d) First Responders

The Clerk had made enquiries to RADAR the First Responder Group based at Rampton to establish what, if any, cover existed for Dunham on Trent and surrounding villages. Caroline Dixon the co-ordinator met with the Chairman and the Clerk on 17.01.07 to clarify that cover does exist for Dunham on Trent and Darlton because they are within the radius limits. In order to cover

Fledborough and Ragnall more volunteers need to be recruited within the Dunham area. The next publication of Trentsider will appeal for volunteers to come forward.

e) Two Casual Vacancies (Ragnall Parish)

A letter received from Bassetlaw District Council stated that there had not been any response to fill the two vacancies for Ragnall Parish and that the Parish Council can now co-opt a person to fill the vacancies. Cllr L Sharpe informed the meeting that she is aware of someone interested in the position. The Chairman said that they would need to write to the Parish Council prior to attending a meeting.

f) Complaint

The Clerk had written to Mavis Smith and informed her with details of the Environmental Health contact at Bassetlaw District Council. After discussion it was agreed that the Parish Council have no further involvement with this complaint.

County Cllr John Hempsall telephoned the Clerk today, Monday 26 February to report that the previous site meeting with PCllr M Matthews, PCllr L Sharpe and a representative from the school was reported to Mr David Lightfoot from Notts County Council Highways Department, who, at the time seemed in favour of the project, but this department does not have the power to make such decisions. When the matter was presented to Ms Karen Emery at Notts County Council, Trent Bridge House, the application was refused on the grounds of road safety issues in respect of the children having to cross a busy road to use the bus shelter. County Cllr Hempsall needed to clarify the precise number of children who would benefit from the bus shelter to add strength to the appeal. The Clerk will write to him with this information. The Chairman informed the meeting of this telephone conversation. After discussion it was felt that the overall view of County Cllr Hempsall did not portray the current situation and the Parish Council were not aware of David Lightfoot being involved.

Cllr I Atkinson had contacted the Chairman prior to the meeting and requested that the Clerk send to him all correspondence to date in order for him to investigate the matter further. Action: M. Annable

The Clerk had writted to Inspector Hamilton at Retford Police Station regarding the poor state of driving through Dunham on Trent by two particular companies, Lafarge and Cannute. The letter had been passed on to PC Bailey who will contact these and investigate.

Reporting on crime in the area over a period of 60 days, PC Bailey informed the meeting that although seven crimes were reported in Dunham on Trent, six of them were associated to one incident involving serious assault. - 2. Most properties have a driveway to park one car.
- The grassed area has been damaged by HGV.
- 4. Tarmac would only provide 4-6 bays.
- Not feasible cost wise.

Cllr Lyon responded by stating that No's 6 &10 do not have parking space. Following a lengthy discussion it was suggested that the residents are surveyed to find out if they wish to proceed with the tarmac at their cost. Another possible solution would be to request that the entrance to the cul-desac be widened to allow vehicles to manoeuvre without mounting the grass. Action: M. Annable

g) Dunham Telephone Box

Cllr R James reported that the telephone box in the village had been modified whereby coins cannot be used to make a call and credit cards can only be used by inserting a number displayed in the kiosk. However, the number is displayed in very small print thus making a call difficult. Cllr James will contact BT to make enquiries and find out if coin operation can be reinstated. Action: Cllr R James

h) High Marnham Power Station

The Chairman reported that as a result of a meeting with Mr Adrian Smith (an official for E-ON) there are plans to demolish the existing cooling towers at the site, use the materials from these as hardcore and rebuild the Power Station in two smaller plants. Mr Smith had asked for the opinion of the Parish Council. The site will be coal fired with coal supplied from Thoresby Colliery by rail. There is some Government funding for this project and it would bring job creation to the area. All present felt that there were no serious objections at this stage.

There was no progress to report on this matter from any previous plans. Clir R James suggested that the road should be closed as a traffic route and be pedestrianised. Clir Lyon and Clir Matthews pointed out that the road is used frequently for traffic travelling to and from Cottam Power Station and Rampton Hospital and closure would appear out of the question. However, the Clerk was asked to write to NCC Highways to suggest the closure. Clir Matthews suggested that a copy of the letter should be sent to District Clir J Hempsall. Action: M. Annable

d) Playground Safety

Cllr R James reported that the play equipment at the playground was set in concrete. The concrete needs to be broken up to remove the footings and a skip will be required to dispose of the rubble. The play equipment can be taken for scrap. The two seats within the play area will need a coat of paint/varnish. The area will then be grassed over. Cllr James's son is prepared to carry out the initial work and will forward an estimate of cost to the Parish Council for approval. Cllr Matthews informed the meeting that this work is necessary as a matter of Health and Safety.

e) Dunham Telephone Box

Cllr R James had made enquiries to BT and Of COM and prepared a report which was presented to the meeting. All the village telephone boxes had been modified without consultation to the Parish Council. The District Council

would have been aware of this procedure but did not inform the Parish Council of the change. The telephones can only operate by use of a prepayment card or a credit/debit card other than emergency services, free phone numbers and BT services. The complication and cost of this change creates problems for users but there is no right to objection. The Clerk was asked to write to BDC and ask why the Parish Council were not informed of the change, also to write to BT and Of COM to complain about the excessive increase in charges. Action: M. f) Parish Meeting

The Chairman asked the Clerk to read out the notes made at the Parish Meeting held Monday 21st May. Several issues were raised at the meeting by the only member of the public who attended – Mr C. Gaisford. In his capacity of Litter Picker for the Parish he had observed the following:-

NCC Building - Mr Gaisford asked if there was any news of the building being demolished. He had met personally with Mr R Statham from NCC Highways Department in September 06 and was told that the matter was being sorted. The Chairman informed Mr Gaisford that the stumbling block with this problem lies with the asbestos roof and the high cost of removing it. Mr Gaisford said that if the roof was removed he would volunteer to clear the site himself.

Reptile Gardens Rent - Mr Gaisford insisted that there should be an increase in the amount of annual rent for the Reptile Gardens. The Chairman said he will investigate the matter. Cllr M Barden supported this request during the Parish Council Meeting. Cllr R James felt that the amount of rent was adequate by comparison to agricultural rating.

Dog Fouling – Mr Gaisford reported periodic increases in dog fouling in all four parishes. PCSO Ciacci informed the meeting that NCC now hold training courses for residents to have the power to issue fines to dog owners. Comments from the meeting felt that this type of confrontation in the Parish would cause animousity. Cllr R James said he had not noticed an increase in the problem.

Grass Verges – Mr Gaisford reported that the verges on Upper Row and Laneham Road had been missed out in the recent work carried out by NCC Highways Department, also that the path between the church and the bridge in Dunham on Trent needs weeding between the slabs.

Road Signs – Mr Gaisford report that there are some road signs around the village of Dunham on Trent, either side of Cocketts Hill that are badly sun bleached and need replacing. Also on the A57 there are poles previously used for road signs that are no longer in use, he suggested they should either be removed or display new signs.

Village Map – The Chairman had noticed that the village map was badly scorched by the sun and requested that the Clerk contact NCC Parish Partnerships and request a replacement map for the external notice board.

Bottle Bank – Mr Gaisford reported that the area surrounding the bottle bank outside the Bridge Inn was awash with other types of refuse, especially cans that are being left by the side of the Bottle Bank. The Chairman asked the Clerk to request a Blue Bin from the District Council.

Parish Seating - Mr Gaisford reported that the wooden seat on The Green is in a very poor state and requested that it should be removed as a matter of Health and Safety.

Several members of the public attended the meeting to air their views about the recent flooding problems within the Parishes. The discussion identified areas of fault within the network of services. It was generally agreed that the main cause of the problem was the water pump in Dunham on Trent. According to the residents present, the pump is antiquated and insufficient for it's purpose. This problem existed before the floods arrived. Another major problem was surface water unable to drain away because of the poor state of drainage. The worst affected areas were Ragnall and St Oswald's Park, Dunham on Trent. The Clerk was asked to write to Severn Trent Water Authority, Bassetlaw District Council and Laneham Drainage Board to request a thorough investigation of these problems. Action: M. Annable

7 Village Maintenance

6 Public Discussion

Flood Investigation by the Parish Council

The Clerk had written letters to Severn Trent Water Authority, Bassetlaw District Council, Laneham Drainage Board and Nottinghamshire County Council to request a thorough investigation of the flood problems along with an invitation to this meeting. The Chairman was very impressed by their attendance and through discussion was able to air the views of the public. The Chairman thanked everyone for attending and went on to say that the floods in the Parish had affected several residents quite badly.

One of the main identified problems was the pumping station in Dunham on Trent. Although Severn Trent claimed to have maintained the pump in September 06 this was in doubt by the community. In respect of the pump tripping out during the flood the response for immediate servicing was good. When it was turned on again the water did subside quickly. Margaret Burrup (Severn Trent) and Sir James Perowne will confer and investigate this matter and any problems will be rectified. Margaret Burrup suggested that new properties built in the area should have several

more rows of bricks to raise them to a safe level. She asked DCllr Isard if the Planning Department request an update on the drainage capacity before consent is given for new homes to allow for additional influx of water. DCllr Isard said that all the necessary enquiries are made for each application and there had been no objections in the past on such matters. Margaret Burrup explained that Severn Trent only become involved if the development of new properties reach 10 or more. Mr Houtby stated that in his opinion the pump was inadequate.

Mr A Birt of Nottinghamshire County Council was unable to attend the meeting but did contact the Clerk and gave the following information:-

The culverts (section of dikes that run underneath the highway) are the responsibility of the Highways Department and have to be maintained by them.

The dikes that run alongside the fields are the farmer's responsibility, should they become neglected to prevent natural flow the Highways Department are responsible to make contact with them. Mr Birt suggested a walkabout the area to ascertain which dike belongs to whom in order to make any future contact.

If storage can be made available locally, the Highways Department can and would supply sand and bags in advance for future use. These should be kept dry and separate and not bagged beforehand because the hessian bags would split.

A useful contact for the future would be Mr John McGuigan (Emergency Planning Team) at County Hall, Nottingham – 0115 9773514. This team co-ordinates the entire operation in the event of a major flood.

In response to an enquiry made to Bassetlaw District Council regarding the distribution of sand bags during the flood a letter received stated that priority was given to the areas in greatest need.

Planning Application by Darlton Gliding Club

Members of the public Mr J Cobb and Mr J Morris attended the meeting in objection to the proposed plans to allow launching of gliders by aero tow and operation of self launching gliders. Also objections to amend the original plan to allow Darlton Gliding club to operate from the site and to increase the number of gliders stored at the site. The main objection voiced at the meeting was that of excessive noise and the effect on livestock in the immediate area as well as this could become a watershed for further developments.

The Parish Council support the objections and will list them accordingly when they have received the plans from Bassetlaw District Council.

Cllr C Dixon reported that a meeting was held to inform local people about future plans for the developments at the hospital. The High Secure learning Disability Unit will be built at a cost of £35 million pounds and will start in January 08. The Medium Secure Unit will now be built at Arnold because of the unsatisfactory location of Rampton Hospital. Also planned for September 08 is a new Training Unit within the Secure area at a cost of £15 - £20 million pounds. A complete smoking ban had been introduced throughout the hospital but the patients are taking this issue to the High Courts as a protest against Human Rights.
